

TOPICS IN CALIFORNIA.

THE MONTEREY FLAG CELEBRATION—TAX ROLLS INCREASED—NOTES OF THE THEATRES.

San Francisco, July 11.—The celebration of the raising of the American flag at Monterey was commemorated at the old Spanish capitol this week. Commodore Sloat, who gave the order for hoisting the flag, was honored by the laying of the cornerstone of a monument. Blue jackets took part in the parade, and for two days the sleepy town was full of life, color and noise. The crowd was so great that most of the people from the surrounding country who came in wagons lived in those canvas-covered vehicles or in tents which they pitched on the hillsides. There was a great barbecue and many sports, in which the cowboys from the big cattle ranches showed their skill in rough riding and in lassoing wild steers.

This city has seen the last of the Rev. Charles O. Brown, who, since he was cast out of the First Congregational Church, because of unministerial conduct growing out of the scandal with Mattie Overman, had been preaching to a small faction of his old congregation in Golden Gate Hall. His audiences had been dwindling every Sunday, and he saw that the end was near, so this week he bade his adherents a tearful farewell and started for the East. The Rev. Dr. William L. Birch, an Englishman, is a candidate for Brown's pulpit.

Among the deaths of the week was that of E. M. Cooper, who for twelve years had been head of the express department of Wells, Fargo & Co. He had been in the express business for forty years, resigning the management of the American Express Company in New-York to accept the offer from this city.

The tax rolls of the Assessor show an increase of over \$30,000,000. The total assessed valuation of city property, real and personal, is \$80,000,000, which will probably be reduced to \$10,000,000 by the Board of Equalization. On this basis the tax rate will be about \$1.10 on \$100 for city and county purposes.

The largest check drawn here on the Sub-Treasury in years was paid this week for work on the battleship Oregon. It amounted to \$75,000, and the proceeds in \$20 gold pieces were taken from the Sub-Treasury to the Bank of California. There were thirty-four bags of the coin, which together weighed 2,900 pounds.

The exports of flour from this port for the cereal year just ended show a marked fluctuation in trade. The shipment of new steamers to city lines in Portland, Seattle and Tacoma cut down the shipments to China 144,100 barrels and those to Japan 13,200 barrels, and a re-shipment of former shipments to Australia which amounted during the year to 123,075 barrels. For the previous two years not one barrel of California flour was shipped, but this year the shipments reached 74,955 barrels.

UNDoubtedly DIED INTESTATE. MRS. LAW'S GRANDFATHER CONFIRMS THE STORY THAT GEORGE LAW LEFT NO WILL.—AS TO THE WIDOW'S AGE. C. Bainbridge Smith, the grandfather of Mrs. George Law and the intimate friend of the late Mr. Law himself, yesterday confirmed the statement published in The Tribune yesterday that Mr. Law had left no will. Speaking on the subject Mr. Smith said: "There is no doubt that Mr. Law made no will. When we were on his yacht, the Alga, about a year ago, the subject was broached, and he said that he would not be sufficient to establish the point. During his recent illness he told me that as soon as he got out he was going to make a will. Furthermore, the lawyer who would naturally have drawn up the will and who acted for Mr. Law in large and important interests knows of no such document."

It was learned yesterday that letters of administration would be applied for by the widow in due course of time. As to the question whether Mrs. Law is still under age, and hence could not apply for letters herself, Mr. Smith said: "My granddaughter is nearly twenty-two years old. The baptismal record, which is in one of the churches of the city, shows her age."

It seems that in making out the marriage certificate a mistake of two years was made in Mrs. Law's age, and when she was read for seventeen, and hence one of the lawyers in the case, in the press, that she was now under age. It is understood that the church in which Mrs. Law was baptized was the Holy Trinity, which is now being torn down. The records are, however, secure. Without the baptismal record, inasmuch as both of Mrs. Law's parents are dead, it is held by some good lawyers that her own evidence as to her age would not be sufficient to establish the point, especially as only a year or two's difference is involved. No difficulty on this point is expected, however.

It was narrated yesterday by one familiar with the history of the Law family, that the elder George Law, after his regular attorney in making his will, and after his death it was found that he had got the late John E. Burrill to draw up the will. The late John E. Burrill, it is stated, was the son had pursued a similar course. Mr. Smith's statement, as well as the lapse of time, seems to set that possible phase of the matter at rest.
