

OLD NASSAU'S BIRTHDAY.

PRINCETON BEGINS HER SEQUENTIAL CELEBRATION.

DEPARTS FROM OTHER COLLEGES AT HOME AND ABROAD WELCOMED—A RELIGIOUS SERVICE IN THE MORNING AND A CONCERT AT NIGHT.

Princeton, N. J., Oct. 20 (Special).—This ordinarily quiet town is all alive to-night, and fairly bristling with the enthusiasm incident to the celebration of the sesquicentennial of the founding of Princeton College, at once the mainstay and the particular pride of the place.

The day began with the busy effort of the residents of the place, whether collegiate or otherwise, to make flags and streamers silently but eloquently testify to their gratitude for the benefits that devotion to the higher education has bestowed upon them.

Once arrived at the beautiful hall they were received by the immense audience gathered therein rising to its feet, as if under a common impulse. The organ pealed forth its most stirring tones under the skilled fingers of the artist seated before the manuals, and when all were seated the choir, composed of alumni and chosen singers from the Glee Club, sang the stirring anthem, "Veni, Creator Spiritus."

Some problems are settled at Princeton. Some issues are not opened to debate beneath its elms. Its philosophy is rooted in the glory of God and the immortality of the soul.

Then President Eliot of Harvard was presented to reply for the American delegates, and he did it in that full, kindly way for which he is noted, alluding to the spirit of fraternity that has come of late years to dominate the communication between institutions of learning.
