ELMSFORD. The Elmsford Taxpayers' Protective Association, which was recently organized here, has issued a statement setting forth the objects of the association, and attacking the town assessors, school trustees and the Sawmill River Drainage Commission. The association claims that the assessors and trustees have unjustly and illegally assessed the property of the neighborhood, and that, if the taxpayers are to meet an additional assessment to pay for the alleged Sawmill River improvement, the work of the assessors of Greenburgh Township is characterized as one of the most

glaring instances of unjust assessment ever perpetrated on a community, and a number of cases are cited wherein there appears to have been much discrimination. The association has retained counsel, and an investigation of the school trustees will follow, for the purpose of having the assessments in the school district corrected, which, it is claimed, will mean a reduction of the tax rate by one-third.

YONKERS. The Yonkers police investigation was resumed yesterday by the Commissioner, and there were some sensational occurrences. J. Fred Hanselmann, proprietor of the Square Hotel, said that he wished to address the Board. At a recent hearing Police Officer May told the Commissioners that Hanselmann had told him that he had given \$30 to Detective James Robinson for the protection of a gambling game in his hotel during the firemen's convention in August, and that Robinson returned the money to him after Hanselmann had refused a demand of \$100 made by Coroner Miles for protection. Also, the hotel proprietor started in to deny that he had ever said so. He was interrupted by President Treanor, who asked him if he desired to be sworn. Hanselmann at first declined, but then decided to take the oath. At this John C. Harrington, Hanselmann's counsel, refused to allow his client to make a statement, either with or without an oath. May was then sworn and reiterated his statement. Hanselmann, under advice of counsel, then denied that he had given Robinson the money. The meeting closed with charges being made against Detective Robinson by the secretary of the Board. The trial was set for next Wednesday. The Commissioners will probably hold the case in which a gambler named John Madden was discharged by Captain McLaughlin, after he was arrested on a charge of gambling, Madden was again arrested two weeks ago for gambling, and has since been in custody by the Grand Jury on three different charges.

WORKING FOR A PARCELS POST SYSTEM. NATIONAL ASSOCIATION OF MANUFACTURERS WILL HAVE A BILL INTRODUCED IN CONGRESS. The National Association of Manufacturers is urging the adoption of a parcels post system in this country similar to that now in operation in England, where it is said to have proved a great commercial advantage. Charles A. Schieren, treasurer of the association, says:

The English system is favored by the association, and it cites the records of our Postoffice Department to prove that merchandise carried in this country is transported at a rate of about the English rate, which begins at threepence a pound and increases as the weight increases. The limit is eleven pounds, and the rate for both the ten and eleven pound packages is one shilling, or 25 cents. According to the last annual report of the Postoffice Department the actual cost of transporting a pound of mail in this country for the estimated average distance is about eight cents, which was the rate for merchandise in the mail at that time it was changed in the early seventies to ten cents a pound, and the rate is now ten cents for parcels post which we now have in this country. That rate is prohibitive, and therefore the express companies get the benefit of this discrimination in their favor.
