



BRIDGE REPORT KEPT SECRET. DISTRICT ATTORNEY PHIBBIN WILL SUBMIT IT TO WILLIAM BARCLAY PARSONS FOR ADVICE.

District Attorney Phibbin, who on Monday received the report of the two engineers appointed by him to make an examination of the condition of the Brooklyn Bridge, said yesterday that he did not think it advisable to make the entire report public for several weeks. Mr. Phibbin was asked if he did not believe it best to make known at once the exact margin of safety of the structure, in order to quiet any apprehension on the part of those who carry it.

"I have seen no indications of alarm on the part of the public," said the District Attorney. "I do not think it necessary to publish anything in addition to what has already appeared in the papers."

"To whom will you submit the report which you have received?" he was asked.

"To William Barclay Parsons. He is an eminent all-around engineer. I shall obtain his advice as to its contents, and then decide whether or not to present the case to the grand jury."

An associate editor of "The Engineering Magazine" is quoted as saying that the Brooklyn Bridge could be duplicated in steel, that would have about twenty per cent more strength, and, therefore, carrying capacity. The present structure, however, has a tensile strength of steel to-day was, he said, due to the remarkable improvement in the processes of its manufacture.

TUNNEL WORK A DANGER. CHIEF CROKER OF THE FIRE DEPARTMENT HAS DIFFICULTY ABOUT KEEPING ALARMS IN WORKING ORDER.

The Fire Department officials have considerable difficulty in keeping the fire alarm and telegraph system in order. Complaint is made continually that the rapid transit tunnel workers are careless and do not protect the wires of the Fire Department as they should.

The department reported to Chief Croker that more than three hundred fire alarm boxes were out of order, and that nineteen engine and hook and ladder companies, covering the district in the vicinity of Broadway between Thirtieth and Fifty-ninth sts., were disconnected. Temporary repairs were made, however, and the wires are again in working order.

Lascelles, thirty-seven years old, of Elimburst, Long Island, account of the Distilling Company of America, was yesterday committed to the Bellevue Hospital insane pavilion for five days for examination as to his sanity. On September 12 Lascelles, who is said to have been under the influence of liquor, boarded an east-bound Thirty-fourth-st. car. He got into an altercation with the conductor and assaulted him. Two passengers were knocked from the car, cutting him badly. He was arrested on the charge of assault, and the next day was arraigned in Yorkville police court and remanded until yesterday for further examination.

Yesterday Rudd C. Rann, a secretary of the distilling company, told Magistrate Brann that Lascelles had been acting queerly, and that he had been committed to have his sanity inquired into. The charge was withdrawn and Lascelles was sent to Bellevue.

JUMPED FROM A HIGH WINDOW TO DEATH. MRS. TILLY LOEWENSTEIN, TWENTY-TWO YEARS OLD, OF WHITESTONE, LONG ISLAND, COMMITTED SUICIDE YESTERDAY, WHILE TEMPORARILY INSANE, BY JUMPING FROM A FIFTH STORY WINDOW AT NO. 53 FIRST-ST. THE WOMAN HAD COME TO THE CITY WITH HER BABY TO CONSULT A PHYSICIAN.

Mrs. Tilly Loewenstein, twenty-two years old, of Whitestone, Long Island, committed suicide yesterday, while temporarily insane, by jumping from a fifth story window at No. 53 First-st. The woman had come to the city with her baby to consult a physician.
