ODELL WILL CARRY STATE

REPUBLICAN LEADERS AT ALBANY EXPECT 40,000 OR 50,000 PLURALITY.

Albany, Nov. 1 (Special).—The political campaign has practically ended in this State, and the leaders of the Republican party are confident that they will again upon Tuesday next be entrusted with political power in this State.

Governor Odell's re-election by from forty thousand to fifty thousand plurality in their judgment will take place.

It is expected that Governor Odell will receive the most votes of any man upon the Republican State ticket, owing to the admiration felt for him by taxpayers, in consequence of his success in accomplishing, practically, the abolition of direct State taxation, and also to the support given him by independent voters who admire his record as an executive.

There is considerable curiosity among politicians to learn if John Cunneen, the Democratic candidate for Attorney General, will profit by the success of his friends in getting him also upon the party column of the blanket ballot assigned to the candidates of the Prohibition party.

While factional fights are hurting the Republicans in some States, they are hurting the Democrats in others. In Ohio the fight for party supremacy between Mayor Tom Johnson of Cleveland and John R. McLean, of Cincinnati, is being fought vigorously.
