

BIG RAID ON "THE" ALLEN PRISONERS NUMBER 275.

Colored Policeman Got Evidence—Lawyer Threatens Policeman.

A raid, elaborately planned and carried out under the direction of Inspector Albert O. Smith, was made yesterday on a poolroom...

The raid was not wanting in sensation. The attacking force was a small army, consisting of Inspector Smith, Captain Wiegand, of the Mercer-st. station; a number of detectives and reserves from the Mercer, Charles, Leonard, East Fifth and West Twentieth st. stations and patrol wagons from each precinct.

At four o'clock the time set for the attack. At every point of vantage policemen were placed to prevent escape. Some were in the yard at the rear, others on the roof, while still others were disposed along Waverley Place and in Sixth-ave.

When the police entered the room, they found in which were found about one hundred and fifty white men. At one end of the room was an iron cage with openings, through which bettors could hand in their money, but access to the cage could not be gained from the room.

The raid was made on warrants issued by Magistrate Cornell. They were granted by Patrolman John E. Tinsdale, colored, of the five-seventh (Brooklyn) Precinct, who is on Captain Piper's staff.

While the names and addresses of the men were being taken, Benjamin Steinhardt, who has acted as counsel for "The" Allen every time his place has been raided, walked into the station. A colored man was being questioned.

"Don't you answer," said the lawyer to the colored man. "Why not?" said Inspector Smith. Steinhardt turned on him.

"What's the use of you making spectacular raids like this?" he said angrily. "I think it is a shame and an outrage."

The inspector interrupted him by telling him to move away from the railing, as he was interfering with the police.

"I won't move away, and you can't make me," said Steinhardt. "I am counsel for these people. I dare you to move me."

The inspector told a patrolman to move Steinhardt. "If you put a hand on me I'll smash you," shouted the lawyer to the policeman.

Turning to the inspector again, he said: "I say this raiding business is a shame. You are denying these people their rights. If you were to do to me what you are doing to them, I'd—and here he lost his voice."

"I don't want to have any trouble," said the inspector. "Let's go on," and Steinhardt eventually subsided.

While this was going on a cab drove up to the station and a man jumped out. Tinsdale arrested him, declaring that on May 20 and 21 he saw him superintending things in the poolroom.

The man described himself as Henry Martin, a real estate dealer, of No. 100 West Eighty-eighth-st. "The" Allen, it is understood, is at Asheville, N. C., in ill health.

All the prisoners but three, who were the "does" named in the warrants, were locked up on a charge of disorderly conduct.

DOG A SUICIDE AFTER SCOLDING. Wanted to Go with Mistress—Jumped from Window.

A Scotch terrier owned by Mrs. Annie Kerrigan, a widow, who lives on the fourth floor of the tenement house No. 2145 First-ave., jumped from the parlor window yesterday and sustained injuries from which it died two hours later.

It struck Henry Smith, a plumber, of No. 3128 Third-ave., on the right shoulder, knocking him to the ground. His shoulder was dislocated and he was removed to the Harlem Hospital.

MINNESOTA'S U. P. MERGER SUIT.

Arguments Begun at St. Paul—Case Brought Under State Constitution.

St. Paul, June 5.—Arguments were begun to-day before Judge Lochren, in the United States Circuit Court, in this city, in the case of Minnesota against the Northern Securities Company and the roads whose control is merged in it.

The arguments may last two or three days. Attorney General Douglas opened the State's case, and will be followed by George E. Wilson, George L. Young, M. D. Grover and C. W. Bunn will present the side of the Northern Securities Company and the Great Northern and the Northern Pacific roads. M. D. Munn will close for the State.

SCHOOL COMPLETES 83D YEAR.

Closing Exercises of Chapin Collegiate in New Building.

The closing exercises of the eighty-third year of the Chapin Collegiate School took place at the new school building, No. 24 East Sixtieth-st., yesterday. They were well attended by parents and friends of the pupils.

After the opening prayer a welcome was extended to the audience by Dr. Henry B. Chapin, who yesterday closed the thirty-sixth year of his principalship. He gave an account of the history of the school and said that owing to the increase in the number of pupils and the contemplated sale of the former school building in Madison-ave., a change to more commodious quarters had been determined on.

He was followed by B. Lord Buckley, as associate principal, who spoke of the results of the last year's work. He referred to the increase in the teaching force of the school by the addition to the faculty of Frederick Phillips Smith, of Harvard, and Hiram Powers, and spoke briefly of the special qualifications of these two teachers.

After the exercises had closed, the work in map drawing, clay modelling, drawing and brush work was inspected, together with the building, which has been entirely refurnished. The eighty-fourth year of the school will begin September 30.
