TRADE IN CHICAGO.

(By Telegraph to the Tribune.) CHICAGO, Nov. 13.—There was another effort today to bring about a rally, and to-day's trade was more successful than recent ones. The bulls had the encouragement of strong prices at St. Louis. The May there was 74 cents higher. This put an end to the anxiety over the St. Louis situation. Prices here advanced to 74. Minneapolis was more active on cash and December, and Duluth was up as much as Chicago. The Northwest cars were up last year's 76, compared with 72, and primary receipts were 1,410,000 bushels, compared with 1,210,000 bushels. But Minneapolis was emphatic in declaring country offerings smaller and in predicting that receipts next week would show the falling crop, which is due to the very severe weather. The St. Louis interest led the buying here, but there was a general turning from the bear to the bull side, every one influenced by the fact that there have been five days of a decline. Argentina shipped 25,000 bushels, and since January, 50,000,000 bushels, compared with 18,000,000 bushels last year. America cleared 1,530,000 bushels, compared with 1,410,000 bushels last year. Cables were steady. Argentina continues to talk high prospects. December sold at 76 and at 76 1/2, and closed at 76 1/2; May, 73 1/2 and 73 1/2. There was a good general milling demand for small lots. Nothing was done in round lots. The seaboard reported twenty-seven loads.

Country offerings were slow. Shipping rates were 600,000 bushels with an especial demand for shipment this week in order to get the Buffalo rate. Cables were up slightly. There was good weather here. Lower temperatures but unsettled weather was predicted. December sold at 74 1/2 and at 74 1/2, and closed at 74 1/2; May, 71 1/2 and 71 1/2. There was a good demand for immediate shipment, with the standard live over December. Shipping rates were 600,000 bushels. There is the same incentive to hurry out of this week that there is to hurry corn. Receipts were up again, with 125 estimated for to-morrow. There was quite general covering, influenced by the strength in other markets. Private houses turned out for cash. Provisions closed strong, though hogs were 10c lower. Lard is dominating, cash lard is over the market. It is expected that the hog market will be higher by December 1. Pork closed 1/2 to 1/2 higher, lard 1/2 to 1/2 higher and ribs 1/2 to 1/2 higher.
