TEAMSTERS TALK STRIKE

Employers Have Broken Agreement, Men Say.

FIGHTING NEW-YORK PLUMBERS.

The latter, which cannot order strikes in New-York because of the arbitration agreement of the Building Trades Employers' Association, has decided that unless the New-York local comes to time quickly it will order strikes on all the outside cities where New-York master plumbers have worked against members of the old union who may be employed in those cities. A \$10,000,000 PACKING COMBINE.

Packers Tired of Paying the High Rates Charged by Western Railroads.

[BY TELEGRAPH TO THE TRIBUNE.] Denver, July 10.—A mammoth packing combine to handle the trade from Denver to the Pacific Coast and the Philippines, China and Japan, is about to be formed by Edward F. Swift, of Chicago, and the Caduays. The principal packing plants of Denver will be embraced in the combination as well as a few minor plants on the coast. The combine will have a capital of \$10,000,000. The plants to be embraced are the Western Packing Company, the Colorado Packing and Provision Company, the Burkhardt Packing Company, of Denver; the "Packer" plant, of Los Angeles; the Swift plant, of San Francisco, and a small plant at Portland, Ore. The cause is the exorbitant rates charged by the railroads for dressed meats.

OCEAN RACE PRACTICALLY ENDED.

Marblehead, Mass., July 10.—The ocean race of the Eastern Yacht Club practically ended just before noon to-day, with the arrival of the sloop Katonah, after she had been nearly ninety-one hours over the course from Brookline, Long Island. Six of the starters had preceded the Katonah to port, while two others, the Aspirant and the Point-tuck, have probably withdrawn, although not yet reported from any place along shore.
