GAME PRESERVE OWNER LOSTS. Right of State Employees to Enter Private Lands Upheld by Referee.

Albany, Oct. 13.—The right of the State Engineer to enter on private lands when necessary to do so in locating and marking county boundary lines, under authority of an act of the legislature, without liability for damages, has just been confirmed by James F. Tracey, of this city, who was referee in a test case of importance.

The controversy grew out of the acts of Charles H. Franigan, first assistant engineer, who, by Chapter 43 of the laws of 1902, was directed to locate and mark the boundary line at the southwestern corner of Franklin County, to determine the extent of a large tract of land recently purchased in that neighborhood.

Mr. Litchfield, whose permission had not been asked, obtained an injunction against the State's employees, and last spring the case was placed in the hands of Mr. Tracey, as referee. The referee agrees with Attorney General Cunniff, who argued that the statute imposing the duty of establishing the boundary was an exercise of police power, and that Mr. Litchfield is not entitled to damages, on account of the importance of the principle involved, the case will probably be appealed.
