After successfully evading detectives for weeks, Lyman S. Andrews, confidential secretary to the late Andrew H. Green and financial agent of the estates of William B. Ogden and Marianna Ogden, surrendered himself to District Attorney Ogden last night.

The forger indictment was based on a check dated December 3, drawn on the Title Guarantee and Trust Company to the order of the trustee of assessments and arrears, and signed "collector account, estate Andrew H. Green, W. O. Green, trustee."

AGENCY LOSES LICENSE.

Sixteen Complaints Against 3d-st. Place—Girls Assaulted There.

As the culmination of a long series of complaints, sixteen in all, against the Metropolitan Intelligence Office, No. 231 3d-st., extending over a period of seven months, the affidavits of two girls, made before License Commissioner Keating at a hearing yesterday, that they had been assaulted by men employed in the office, led to the revocation of the license by the commissioner.

The employment agency, which is run in the name of Stanislaus Kosinsky, but is really conducted by his partner named Zimmerman and Marie Kosinsky, the wife of the alleged proprietor, has had an unsavory reputation for some time, according to the Commissioner, whose inspectors have made frequent reports on minor violations of the license law.

At the hearing yesterday in the Commissioner's office, Regine Maybrick, fifteen years old, of No. 284 East 2d-st., testified that on January 12, of this year, she visited Kosinsky's place and applied for employment as a servant. She told the Commissioner that she was assaulted in the place by a man named Julius Baker, and that she was rescued from him by Samuel Zimmerman.

Minnie Gold, nineteen years old, of No. 15 North Moore-st., testified that she was assaulted in the place by Max Goldberg, an employe of Kosinsky's, who was in charge of the office at the time. Another girl, who did not give her name, testified that she applied to Mrs. Kosinsky for a position, and received the address of a disorderly house, to which she did not go. Who the girl complained to Mrs. Kosinsky, she declared that the latter struck her and called her bad names.

TWO MEN CAUGHT IN COURT. Were Listening to Case—Magistrate Denounces Alleged Seducer.

While they were sitting in the Harlem Court yesterday to hear the outcome of a case against an alleged procurer, two men who, it is alleged, are procurers, were caught in a trap. They were arrested by a police officer who was in the court room.

When Frank Marato, an Italian barber, twenty years old, of No. 168 Orchard-st., was arraigned before Magistrate Cornell in the Yorkville police court yesterday, charged by Josephine McManis, twenty years old, who lives with her mother at No. 44 East 66th-st., with seducing her under promise of marriage, she said:

"This is one of the most repellent cases I know of. I shall have no mercy on this scoundrel." The girl testified that she met Marato at Brunner's dance hall in the Bronx. After he had seduced her, he took her to a disorderly house in 52d-st., where she was kept for some time.

"This prisoner is the worst kind of a scoundrel," said the magistrate. "I believe every word this girl has said. I shall have no mercy on this fellow. He has seduced a young girl and is now being permitted in dance halls of this kind. I shall hold this prisoner for trial in the fall, and will show him not one particle of mercy."

BARR ATTACKS WILLIAMS. Makes Charges Against Former's Conduct of Seaboard.

Portsmouth, Va., Feb. 8.—President James M. Barr of the Seaboard Air Line Railroad, in reply to attacks made by ex-President Williams of that line, of mismanagement of the road's property, mailed to-day letters to stockholders.

Barr charges Williams with receiving a commission for using the Seaboard's name in financing the Savannah and Statesboro. Referring to the statements of Williams that the rate of grade revision as outlined by Barr is excessive, the latter declares that the former president is guilty either of a willful misstatement of facts or else he is "incapable of distinguishing right from wrong."

Barr asserts that he declared in his remarks on the budget that the income of the system would not justify reducing the grades to 1 per cent, excepting in one instance. He charged Mr. Williams with carelessness in the building of the Atlanta and Birmingham line, charging that the connecting link was purchased before a survey of the remaining of the line was made and that regard to cost within reasonable limits.

TELLS OF BEING DRUGGED Mrs. Peace Testifies in Divorce Trial of Hotel Incident.

The trial of the counter suit against Mrs. Martha C. Peace, brought by her husband, Frederick C. Peace, began yesterday. Mrs. Peace seeks an absolute divorce. Harry E. Bryan, who acted as a detective and followed Mrs. Peace and a strange man to different hotels in this city, gave testimony on cross-examination.

Arthur W. Peace, brother of the plaintiff, testified as to the Morton House incident. John E. Peace, another brother, corroborated him. Mrs. Peace testified that on Saturday night, April 30, a Mr. Lewis came to her and wanted her to rent a house in the Bronx and take him and a woman to board. That night he invited her and another woman to go to the Morton House to dinner.

She said: "They asked me to drink several times, and I refused. Mr. Lewis and another man went out for a few minutes, and the waiter brought me a glass of sherry. I found a precipitate in the bottom of my glass, and I told them that there was something the matter with the wine."

"Why," said they, "what do you know about sherry?" and I told them. I attempted to rise from the table. I did get up, but my head was so dizzy that I fell back. I was in a room and the sun streaming through the window. I got out of bed some way and crawled on my hands and knees to the door. I saw a man standing in the doorway. The door was locked from the inside."

Mrs. Peace testified that she saw Lewis again on Monday afternoon. "So sorry you met with the accident on Saturday night; we had to leave you downtown. The doctor told me about going to the Dewey Theatre, where she had more sherry. It again made her ill. They went to the Morton House and she and the baby were taken to a room by one of the theatre party. He left them there to go to get Mrs. Peace something to eat. She said she saw nothing. He brought back a glass of milk for her, and a glass of something else for me. I remember nothing. I saw my husband and the men in the room."

THE CASE WILL GO ON TO-DAY. Curare or curara is a resinous extract of certain trees used by the South American Indians to poison arrows or blowgun darts. Except in large doses it can be eaten with impunity, but the introduction of the slightest quantity of curare causes almost instant death. Curare acts on the nerves, paralyzing the motor centers, and brings death through suffocation by paralyzing the muscles of the throat.

CHICAGO DOCTOR THINKS HOCH ADMINISTERED CURARE. Chicago, Feb. 8.—Curare, one of the most subtle and deadly poisons known to science, is believed by Dr. Joseph Springer, formerly coroner's physician, to have caused the death of Johann Hoch's wives. Dr. Springer is convinced the fatal drug was administered by means of engagement or wedding rings.

Dr. Springer told the jury that he had analyzed the rings and found traces of curare. He said: "By turning the rings in the Jefferson market yesterday. He had been held on a short affidavit charging that he was 'wanted in the city of Chicago' for the crimes of homicide and bigamy." He appeared cheerful. The extradition papers arrived from Albany yesterday morning. Hoch reiterated his desire to waive all formal proceedings and go at once to Chicago. He started for the West in the afternoon.
