BILLS SIGNED BY THE GOVERNOR.

Albany, March 2.—Governor Higgins has signed the following bills: Mr. Charles's, authorizing the Amsterdam water commission to establish ordinances for the protection of the water supply. Senator Elsbach's, authorizing New-York City to issue corporate stock instead of revenue bonds to the amount of \$1,000,000 for improvements to the Metropolitan Museum of Art. Senator Elsbach's, authorizing the medical college laboratory of the City of New-York to transfer its property to a university, college or other institution of learning.

HIGHWAY AMENDMENT PASSES SENATE.

Albany, March 2.—The Armstrong constitutional amendment bonding the State for \$50,000,000 for the improvement of highways passed the Senate today by a vote of 47 to 12. The amendment was introduced by Senator Cassidy and Hinnen voting in the negative.

GAS BILL REPORTED.

Committee Lets Fitzgerald Measure Out Without Approval.

Albany, March 2.—Contrary to general expectation, the Senate Committee on Miscellaneous Corporations to-day reported out the Fitzgerald 70-cent gas bill, not as bills are usually reported, with the approval of the committee, but in the perfunctory fashion that puts the measure before the whole Senate without in any sense expressing the approval of the committee. In other words, this committee, having by its previous vote expressed its disapproval of the measure, to-day, put it out, that the whole Senate, instead of the committee, should bear the responsibility for the failure of gas legislation, and that its members might be freed from the charge which has been made that it was "holding up" the bill.
