

CELLS FOR ICE MEN. VIOLATED TRUST LAW. May Escape Workhouse and Fine by Making Restitution.

Toledo, June 25.—In the Common Pleas Court today Judge Kinkade gave the maximum sentence of \$5,000 fine and one year in the workhouse to five ice men guilty of conspiracy in restraint of trade.

NEED NOT PAY TRUST. St. Louis Court So Decides in Suit Against Plumber.

St. Louis, June 25.—A notable anti-trust decision was handed down in the Circuit Court today by Judge Ryan, who ruled that a purchaser need not pay for goods bought from a so-called trust.

The Cahill-Swift Manufacturing Company had bought suit for \$30 against the firm of Walsh, a plumber, charging that Walsh had bought goods from the value of the judgment asked, and had refused to pay for them.

Walsh acknowledged this, but his counsel termed the company a "trust," and argued that Walsh need not pay for goods bought from a trust any more than he would have to pay a gambling debt.
