

TRIED TO SAVE MASTER.

Dog Pulled Trousers to Warn Him of Approaching Trains.

August Barghen, a pen manufacturer of Morris Park, Long Island, was instantly killed while crossing the railroad tracks at the Morris Park station last night. Mr. Barghen evidently did not see or hear an electric train which was approaching at a high rate of speed.

Witnesses say that a fox terrier which accompanied him lost its life while trying to save its master. The dog apparently saw the train and realized the danger, for it seized one of its master's trouser legs in its teeth and tried its utmost to pull him back.

The motorman of the train was arrested by order of Coroner Ambler, of Jamaica, who later paroled him until the inquest. It is said that the electric train frequently reach a speed of sixty miles an hour at this point.

Mr. Barghen leaves a wife, three sons and two daughters, all under forty-four years old. The body was removed to an undertaker's by permission of the coroner. Cards in his pocket led to his identification.

TO STIFFEN BLASTERS' REGULATIONS.

Division of Subject Probable Action of Commission—Blasters at Hearing.

Deputy Fire Commissioner Bonner said yesterday afternoon, after the hearing of the Municipal Explosives Commission, that the regulations controlling the handling of explosives in the city limits would be revised, and that the probability of a new blasting certificate act had been necessary only to go to Inspector Wolf and answer questions put correctly.

In the future the work of blasting, it is expected, will be divided into three departments—tunnel, trench and excavation blasting. To obtain a certificate in all three branches it will probably be necessary to pass an examination in each.

Ten foremen blasters attended the meeting yesterday at the invitation of the commission. It was the unanimous opinion of these men that the majority of the accidents were caused because one man did the work of two or three.

They showed that the blaster, when he arrived where the hole had been drilled, did not know whether the hole was to be filled with dynamite or with a much heavier blast than was necessary, causing accidents. It was unanimously decided that the blaster should be required that the man who did the blasting should oversee the drilling.

The commission will take up the matter of explosive stove polishes and will ask for some sort of legislation to do away with the sale of such articles.

SAYS HE TRIED TO SAVE M'KINLEY.

Insane Negro Arrested in Atlantic City Told Story in Streets.

Atlantic City, March 22—A burly Negro, who says he is James Parker, who risked his own life in an attempt to save President McKinley when the latter was assassinated by Czolgosz at Buffalo, was arrested here to-night in a demoralized condition. Parker wandered about the streets all day, creating crowds by standing on corners and telling his story.

Police surgeons say he is unquestionably insane, and friends here attribute his insanity to the shock of the consequences of the honors showered upon him.
