He Defines His Attitude on Local and Special Legislation. Albany, April 17.—Governor Hughes to-day vetoed the bill of Assemblyman Sinclair providing for a special commission to build a new Columbia County courthouse at Hudson, and that of Assemblyman Garbe, providing for an increase in the force of employes at the Queens County Jail. These bills were both the subject of controversy in the Legislature.

FRATRICIDE PLEADS SELF-DEFENCE. William Boyne, an ex-patrolman, who was shot on Tuesday night by his brother, George, in the home of his mother-in-law, Mrs. Johanna Mack, at No. 219 Hamburg avenue, Williamsburg, died last evening without regaining consciousness in the German Hospital. His brother has been held without bail. William Boyne said the shooting was done in self-defence.

MR. STUART'S MURDERER SENTENCED. Friday, April 17.—The murderer of William H. Stuart, an Englishman, who was American vice-consul at Batavia, and was killed at his country place near there on May 28 last, was sentenced by a court martial yesterday to be hanged, but in view of the fact that the sentence was commuted to life imprisonment, two others who were accused of complicity in the crime were acquitted.

OPPOSE INCREASE OF TEACHERS' PAY. Board of Education Representatives to Protest at Legislative Hearing. The Board of Education will take a stand against the women teachers' salary bill now pending before the Legislature. There will be a hearing at 2 o'clock to-day before the Cities Committee of the Assembly. This hearing will be held at the request of President Egerton L. Winthrop, Robert L. Harrison, chairman of the bylaws committee, and Abraham Stern will appear for the educational authorities.
