

HIS IDEAS ON CHARTER.

MAYOR GIVES ADVICE.

Would Do Away with Borough Presidents and Minor Boards.

As Mayor McClellan will be unable to attend many of the meetings of the Charter Revision Commission, appointed to revise the charter of the greater city...

There are entirely too many city departments, he believes, and suggests to the commission that the number be reduced by consolidation.

He regrets that his official duties will prevent him from attending the sessions of the Charter Revision Commission as often as he should wish.

Summarizing the various features of his plan in the most general manner, he suggests:

First.—That the revised charter should be as concise as possible, and that the mass of minor provisions contained in the present charter should be eliminated...

Second.—That the office of Borough President should be abolished and that the responsibility for the execution of the various branches of the city government should be centered directly on the Mayor.

Third.—That the number of city departments should be reduced, consolidating those which have no possess more or less similar functions, and doing away with much of the conflicting jurisdiction which exists at present.

Fourth.—That the Board of Estimate and Apportionment should be composed, not of city officials, but of members elected for a definite purpose. That the Board of Aldermen should be organized, reduced in size, and that many of the minor city departments should be abolished.

At the outset, I believe that every effort should be made to frame the new charter upon the simplest lines, and to briefest possible terms. In fact, the most satisfactory charter, from an ideal point of view, would be one which is readable by the state to the citizens of the city allowing them to govern their municipality according to rules to be established by the Mayor.
