

HONOR NEW JUDGES.

Bartlett, Gaynor and Others Speak at Brooklyn Club.

All the successful judicial candidates in the last election in Kings County were the guests of the Brooklyn Club at a dinner last night.

Word was received from the home of Chief Justice Hirschberg, who is a member of the club also, that his condition was so much improved that for the first time in several days an evening had passed without a consultation of physicians regarding his case.

Judge Bartlett was the first guest called upon to speak. He dwelt upon the influence of the Brooklyn Club on both the bar and the bench for the general good of the community.

In introducing Justice Gaynor, Mr. Groat said it was the first time he had had occasion to introduce him in public, although he had been his law partner for fifteen years and his friend for much longer.

Dr. Leigh Hunt Makes Urgent Appeal for \$5,000.

"When The Tribune published an appeal for help for destitute artists last summer," said Dr. Hunt, "we received in answer to it about \$50 in cash in a few days. It was exceedingly welcome, and was spent at once for the relief of urgent cases."

"We could place a number of octogenarians in comfortable homes for the remainder of their days, pay the cheap rent of several aged artists who are still struggling to support themselves, pay doctors' bills for some, and buy food and fuel for others, who are penniless. All these cases have been investigated and are unquestionably deserving."

LOCKJAW FOLLOWS VACCINATION.

Little Schoolgirl Dies in Brooklyn—Question of Cause Argued.

Coroner Brewer, in Brooklyn, issued a certificate yesterday declaring that Ethel O'Keefe, aged six years, died of lockjaw following vaccination. The vital statistics bureau had refused to issue a burial permit, because tetanus, or lockjaw, had been given by the attending physician as the cause of death, but without the addition of any details.

The coroner found that the girl, who is the daughter of Peter R. O'Keefe, a Canadian tobacco merchant, had been vaccinated eighteen days ago by a woman physician employed by the Public Health, that she might be admitted to Public School 4. Last Sunday the child was seized with convulsions, but not until five doctors had been summoned was a satisfactory diagnosis made, and it was then too late to afford any relief. The little girl died on Wednesday.

There is no evidence that the vaccine virus used was not pure or that the inspector of the board showed carelessness.

Dr. Travers R. Maxfield, assistant sanitary superintendent in charge of the Brooklyn Health Department, said last night:

"I have heard nothing about the case except what I read in the newspapers, but it seems impossible that vaccination should cause the death of a child so many days after she had been inoculated. The suggestion that the vaccine was impure is not worth considering."

"The virus used by the Health Department is made and handled with extreme care. A quantity sufficient to inoculate fifty persons is placed in a tube, and it is applied with a new sterilized orange-wood needle to every individual. The O'Keefe child was vaccinated with a number of other children and from the same tube, and no other fatalities have been reported. I think probably the child scratched the wound when her hands were soiled and became infected."

DAYLIGHT BLINDS TUNNEL MULES.

Two Hundred and Fifty Brought to Surface for First Time in Two Years.

All the mules which have been used in the tunnel boring between Jersey City and Cortlandt street were taken from the tube at the Jersey City shaft yesterday afternoon. There were about two hundred and fifty animals brought up in the lift, and it was the first time they had seen daylight for nearly two years. As soon as they were liberated from their cage lift they acted like young colts, kicking, rolling and nickered. Their attendants did not anticipate such a demonstration of joy on the part of the sluggish beasts as they had grown to know them between the street and river, and were unable to restrain them.

Several patrolmen were called in to aid in preventing a stampede, and with difficulty succeeded. The sunlight blinded the animals, and several hundred passengers alighting from the trolleys to cross the river on the boats, enjoyed the novelty of watching the brutes bump into each other as they romped about. As soon as each animal had been blinded the keepers were able to handle them.

Electric service in the tubes has been installed and the cars are no longer hauled back and forth under the river by hand power. The beasts taken from the lower tunnel will be put in the construction of other tubes being built further up the river.
