

EDWARDS MURDERED. ICE SEALS UP RIVERS. BOATS CRAWL ACROSS.

REFUTE SUICIDE THEORY. Did Not Kill Himself in Hiller Homestead, Experts Say.

Traffic Badly Congested Until Ebb Tide Comes to Rescue.

Evidence to show that Charles A. Edwards, of this city, who was found dying at the Hiller homestead, in New Haven, on January 3, 1906, did not commit suicide, as decided by Coroner Mix of that city, is now in the possession of W. H. L. Edwards, the nephew of the dead man.

The entire harbor from Hell Gate, in the East River, and from Grant's Tomb, in the North River, to the Lower Bay, was filled with ice yesterday and traffic was greatly congested.

A big army of men was busy all day clearing the city's streets of snow. Good progress was made in the downtown districts.

One puzzling thing in the researches of Mr. Edwards and Mr. Wolf was the apparent disappearance of blood that was found on the floor from hatch of the attic door.

It seems that the pistol was found in the yard with the butt pointing away from the house, the reverse of what it would have been had it been hurled out.

KEPT OUT OF HAYTI. Merchant, Not Allowed to Land, Will Protest to Washington.

Alfred V. Leaman, a merchant of this city, who sailed for Hayti on the Hamburg-American steamer Alleghany several weeks ago and who was arrested yesterday on the Dutch steamer Prins Willem I.

He went to Port-au-Prince to transact business for his company, and took an American passport, as he had done on many visits to the island.

Mr. Leaman sent another request direct to the Haytian general at Port-au-Prince—he says there are a hundred generals there in uniform—and was informed later by that official that he had better leave Haytian waters by the steamer Prins Willem I that afternoon.
