ECLIPSES EVERY MARK WITH DISCUS.

Eisele Gains Unexpected Point for America by Plucky Race in Steeplechase.

London, July 18.—While this was distinctly a day of British triumph in the Olympic games, America had no cause to worry, for Martin Sheridan, the great Irish-American athlete, club man, hurled the discus from the pedestal of ancient Greece without a tremor.

The two great grandstands at either end of the stadium, the admission to which is fixed at a shilling, were completely filled with a crowd similar to that which attends football matches on half-holidays. The covered stands where the seats are reserved also held a much larger number of persons than on any other previous day.

The weather, however, was no respecter of persons. It was cloudy and dull all morning, but toward noon the sky cleared and it looked as though the afternoon would be fine.

France's protest, also in the cycling event, was added to by another to-day, Schilles protesting Jones, the winner of the 500-meter event, in the 100-kilometer race, for which he had not qualified.

There were four of the United Kingdom team—Russell, Robertson, Holloway and Sewell—in this event, in addition to Eisele and Galbraith, the latter representing Canada.

Then the Stars and Stripes went to the masthead, proclaiming the victory of the Americans in the discus throw. The flag got a rousing cheer, and when Sheridan and Horr walked out in the arena they received an ovation from the Americans.

KEEN CYCLE RACING. Goerke Wins Eastern District Championship at Elkwood Park.
