"Dependent further states that the man whom I saw with said Rae Tanzer at the Circle at the time referred to was a tall man, nearly six feet tall and weighed 170 or 180 pounds, was clean shaven and had a florid complexion, and my recollection is that he wore considerable jewelry at the time, but he was not James W. Osborne, as I know from the photograph of the said Osborne, and I told Rae Tanzer so at the time."

Christiansen said that any further facts which he knew about the case would be brought out Wednesday, when he appeared in court as a witness against the girl. When asked about Miss Tanzer's relations with the Psychological Research Society he said she merely attended the weekly meetings.

Girl Makes Statement.

Three Slade Brothers, Benjamin, Maxwell and David, of the firm of Slade & Slade, of 209 Broadway, counsel for Miss Tanzer, made much of the fact that the complainant against her and the mysterious witness, "Oliver Osborne," did not appear before Com-

missioner Houghton yesterday when their client was arraigned.

As soon as the miller got out on bail, she asked a statement at the office of her counsel, in which she said the charges made against her were "made out of the whole cloth" and that the complaint she had made against James W. Osborne was "absolutely true in every particular."

"The charge against me in the criminal proceedings is merely an attempt to whitewash the fact that I was in the newspapers for the time being, at better than any one else that he is guilty of the charges I have made against him, and I defy him to disprove my claims. I have never seen or known James W. Osborne, nor have I had any dealing with any person save James W. Osborne. I stand ready to prove every single one of these allegations. I have made at the trial of my case."

A strange feature of the case was revealed yesterday by Harold Spielberg, attorney for the Southwestern Surety Insurance Company, of 345 Broadway, who furnished the bail bond for the defendant. A man unknown to him called at his office, he said, and insisted on indemnifying the bond for Miss Tanzer. The man took the lawyer to the Mechanics and Traders Bank, drew \$5,000 in \$100 bills and turned them over to the bondsman. It developed later that the mysterious man was Milton Hertz, former Assemblyman, who lived at 301 Fulton Street, Brooklyn. When asked who he represented Hertz refused to say.

"I represent a client who wants to see justice done," said Mr. Hertz, "and

that he is personally acquainted with and knows Rae Tanzer, the plaintiff herein, whose residence until recently was 952 Aldus Street, The Bronx, and formerly lived at 35 West 112th Street, according to the information given deponent by said Rae Tanzer.
