

COALITION FINDS FEW ADVOCATES AMONG BRITISH

LORD CURZON TO JOIN CABINET

London, May 20. The coalition ministry started business this morning, when an important conference took place at 10 Downing Street, the residence of the Prime Minister, those present including Mr. Asquith, Sir Edward Grey, Lord Curzon, Reginald McKenna, Arthur Balfour, Arthur J. Balfour, Lord Lansdowne and Austen Chamberlain.

RUSSIANS LUNGE AT FOE TO SAVE PRZEZSL FORT

Make Desperate Counter Attacks Around Jaroslav and Sieniawa.

AUSTRIANS CLAIM 5,600 MORE CAPTIVES

Teutonic Allies Gain Further Ground Along Upper Dniester, Vienna Reports.

London, May 20. The Russians, awaiting reinforcements, are making desperate efforts to hold their positions along the middle stretch of the River San and prevent the recapture of the fortress of Przemyel by the victorious Austro-Germans. The official reports from both Berlin and Vienna note particularly the violent Russian counter attacks north of the Przemyel stronghold. The Austrian communique declares that 5,600 more Russian prisoners were captured in battles to the southeast of this sector.

Petrograd, though realizing the gravity of the situation, is inclined to a hopeful view. The readiness with which the Russian armies in Galicia have taken up their new defensive positions is accepted as satisfactory evidence that all is well with the main strategic plan of campaign. After a week of frantic assaults in dense masses, accompanied by appalling losses, the Austro-Germans are beginning to show signs of fatigue, while the Russians appear to have quite recovered from the effects of their first duster, caused by the German onslaught, the dispatch from the Russian capital says. Grand Duke Nicholas is quoted as describing the battle around Przemyel as one of "tremendous pressure."

Russia Admits Loss. The Russian official report issued late to-night, while describing a success on the left bank of the Vistula, admits the advance of the Austro-Germans around Jaroslav and Sieniawa, east of the San River, and in the south. The communique says that the Russian forces in the region of the left bank of the Vistula, south of Lubica, and on the whole Galician front continued with constantly increasing intensity.

Advanced Trenches Taken. To the south of Przemyel the attacks of the enemy were conducted with particular intensity in the sector of Lupkow, the Iwaghi River and Strawiec, where the enemy succeeded in capturing several of our advanced trenches. "On the front of Drohobycz, Stry and Dolina we have continued to repulse tenacious attacks and inflicted immense losses on the enemy."

Russian Losses Great. The Vienna official statement issued to-day says: "To the east of Jaroslav and near Sieniawa (north of Przemyel), strong Russian attacks were repulsed with severe losses to the enemy. "The allied Germanic troops are gaining ground in the east and southeast of Galicia. We captured an additional 5,600 prisoners in battles along the Upper Dniester. In one sector to the north of Sambor the enemy retreated from their main defensive position."

German Take Many Prisoners. Berlin claims great success in the Baltic region and Northern Poland, the capture of 900 prisoners in an engagement on the Dubysa River, 500 in the storming of a hill north of Hoduski and 2,000 prisoners and 200 machine guns in battles south of the Niemen. Of the latter engagements the official report says: "Russian forces advancing south of the Niemen were completely defeated at Grycsenabuda. Symmetrically was defeated the enemy's forces are fleeing in an easterly direction into the forest. Minor divisions still are holding Surtali. The losses of the Russians in killed were very heavy."
