Two Attacks East of the Meuse Repulsed. Despite Liquid Fire. Gerard Silent on Sussex; Capital More Anxious.

Washington, March 30.—Considerable uneasiness has been aroused in Administration circles by Ambassador Gerard's continued silence on the Sussex attack. Three days have elapsed since he was instructed by the State Department to inquire of the German government whether any of its submarines torpedoed the Channel steamer, and so far no answer has been received.

One Lone German Seizes British Steamer at Sea

Wilmington, Del., March 30.—A lone German stowaway captured the British steamship Matoppa off Sandy Hook at 8 o'clock last night, and after robbing the captain and his crew, rifling the ship's papers forced Captain Bergner and his crew of forty men to pilot the vessel inside the Delaware Breakwater. The Matoppa was bound from New York for Vladivostok. She arrived off the Delaware Breakwater soon after noon to-day, and it was only the vigilance of the superintendent of the Maritime Exchange reporting station that kept the stowaway from escaping.
