

Find Varotta Boy's Body in Hudson River

Discovery Made as Mother Prays at Shrine and Believes Her Child Has Been Recovered Alive

Lad Slain on Land, Bruises Indicate

Corpse of Kidnap Victim Floats to Shore Near Nyack; Long in Water

Giuseppe Varotta, the five-year-old boy, who was kidnaped May 24 from in front of his parents' home, 334 East Thirtieth Street, was found dead yesterday. The discovery of his body was a startling verification of threats which had been made to his father as recently as last Monday by letter that his boy's body would be found floating in the river.

It was within the limits of tide flow on the shore of the Hudson at Piermont, N. Y., that the body was found, on a promontory known as Piermont Pier, which is the southern limit of the Tappan Zee. Because of the condition of the body, which had been in the water for some time, Coroner E. C. Plender issued a burial permit and it was interred at once in Oak Hill cemetery, Nyack.

Body To Be Disinterred To-day

Salvatore Varotta, the boy's father, had no doubt whatever, however, after examining the clothing that was on the body, that it was that of his son. The body will be disinterred to-day. Varotta spent the night at Nyack to be present at the exhumation. Those who saw the body said it was that of a child who had died struggling either against drowning or against an attack. Marks on the body led some to believe that the latter was the case and that the boy had been killed before being flung into the river.

Eager tears of happiness which weeps of alternating hope and disappointment had fallen to exhaust weeping in the eyes of Giuseppe's mother as she knelt in prayer. She knew, she said, that at last her boy had been found. They were looking for the body of the boy at Piermont and it was the clothing of her Giuseppe. There was the sailor blouse with its blue collar and the khaki trousers, the brown faced shoes that had been half-worn, the brown stockings and—dear—dear of all—the little red garters which she had found time to delight Giuseppe by making an apt of demands made upon her one by housewife that the sewing that must be done before the new baby came.

The saints were good to her, said Mrs. Varotta. All her trouble was over now and soon would be over. She never had had. Hundreds of boys might have worn sailor blouses with white collars and cuffs, khaki trousers, brown faced shoes and even half-worn shoes, but who but Giuseppe had such red garters?

At every footstep on the stairs Mrs. Varotta rose to start for the door. At any moment she felt that door might open and Giuseppe ride in upon his father's shoulder as he so often used to do when he had gone to the corner to meet his father.
