Increased Appropriation Asked for New Vessels and Heavier Guns. WASHINGTON, Nov. 29.—Chief Ensign of the Navy Bureau of Construction and Repairs reports that the amount appropriated for the present year, 1879-80, was \$1,500,000; amount expended, \$1,400,000. The report, however, in detail the work performed at the several yards in the construction and repair of vessels, and gives the present number of vessels of each class in the navy, as follows: Cruisers—Steamers, 20; sailing ships, 4; monitors, 8; torpedo-boats, 2; etc. Ordinary—Steamers, 18; sailing vessels, 8; monitors, 3; torpedo-boats, 2; etc. Receiving Ships—Steamers, 5; sailing ships, 3; monitors, 1; etc. Ships—Steamers, 1; sailing ships, 1; monitors, 1; etc. Public Marine School—Steamers, 3; monitors, 1; etc. Tugs of all kinds and auxiliary vessels, 25.
