Abolish the Diplomatic Establishment.
The House of Representatives has once more shown its indisposition to take steps for diminishing, still less for abolishing, the foreign diplomatic service.

It is doubtful, however, whether a better opportunity could be given for this reform. During Mr. HAYES'S incumbency, the foreign service never spoke the local language.
