The recent election in Michigan for Judge of the Supreme Court has been received in some quarters as a great victory for the Democrats.

Judge Covert is well known as an eminent jurist who has adopted extreme temperance views, and was represented as having too often sided with great corporations.

The Democrats put up Major Morse, a gallant Union soldier, who lost an arm in the civil war, who openly opposed summary legislation, and advocated complete personal liberty as the guaranteed right of the citizen under the Constitution.

The so-called temperance issue was the turning point of the contest, and was made so by the Prohibitionists. They forced the fight, and they got badly beaten.

This result cannot be properly described as a political triumph, although the Democratic candidate for Judge of the Supreme Court was elected a large majority.

The temperance agitation in Michigan, in Iowa, in Wisconsin, in Illinois, and in Kansas has broken the scope of the natural obstacles, and introduced an element of discord into the Republican party which threatens to destroy its ascendancy in these States.

Although we cannot look for a full and trustworthy account of the recent remarkable events in Central America before the arrival of the mails from Guatemala, certain decisive facts may be regarded as established.
