

A CONFERENCE OF PRELATES

ARCHBISHOP CORRIGAN GOING TO BALTIMORE TO MEET THE CARDINAL.

Archbishop Corrigan, President of a Private Meeting of the Clergy in New York—Dr. McMillan, Bishop of New York, and other Prelates to meet the Cardinal.

Archbishop Eider of Cincinnati will start for Baltimore this morning. He goes in response to a telegram from Cardinal Gibbons. He will be absent for four or five days. The Archbishop is expected to arrive in Baltimore on Monday. It is believed that he will be in Baltimore for a conference on Church matters.

Immediately after the receipt of the telegram from Cardinal Gibbons, Bishop Mace of Covington was summoned to the archiepiscopal residence in Cincinnati, and was in conference with Archbishop Eider during the entire afternoon and evening. The Archbishop in the mean time refused to see any callers.

The greatest importance attaches to a conference of archbishops of the Roman Catholic Church as Archbishop Eider and Cardinal Gibbons at this time, according to all indications, is a matter of great importance. It is believed that there are some rumors that the Church is about to discipline the Rev. Dr. Edward McMillan of this city for active participation in the Henry George movement.

The result of the conference of the distinguished prelates will be awaited with interest. The proceedings were held at the residence of the Archbishop on the corner of Fifth and Orange streets, together with those of the parishes of Orange, Ulster, Rockland, and Sullivan counties, held a conference yesterday in St. Michael's Church, on Ninth avenue and Twenty-second street. The proceedings were held in Latin. Archbishop Corrigan presided, and Father John J. Murphy acted as moderator. The subjects discussed, said one of the priests last night, "were purely doctrinal and solely of interest to the clergy."

"Were the theories of Henry George discussed?"

A part of Archbishop Corrigan's letter which relates to certain unorthodox doctrines was alluded to," answered the priest.

The conference will hold another session to-day.
