

MARK TWAIN'S BOOKKEEPER.

SCOTT CONFESSES THAT HE STOLE \$50,000 FROM WEBSTER & CO.

He Took the Money in Speculation and Extraneous Living—His Wife and Children.

Frank M. Scott, lately the bookkeeper of Charles L. Webster & Co. Mark Twain's publishers in Newark awaiting extradition on a charge of embezzling from the firm, has confessed that he robbed the firm of \$50,000.

Ever since his arrest and until Wednesday Scott had persistently asserted his innocence. On Wednesday, however, he changed his mind and confessed in the jail to Mr. Charles L. Webster and Publisher Hall, his partner.

The Edward Hanson, Scott's counsel, said that his client had already confessed to him personally and wanted to make a clean breast of his dishonesty to his employers, too.

Scott said that he began his peculations the very first month he entered the firm's employ. In July, 1885, that month he stole \$100, he said, and took \$500 the next month, and kept on doing so until November he had stolen \$1,700.

He said that he was driven to dishonesty by being nagged by creditors to whom he owed about \$1,000 when he left Hanes & Co. in Newark to enter the employ of Mr. Webster. He said that he took the money intending to pay it back when he could.

He concealed his thefts by means of false entries and false money statements. He took \$100,000 from the firm, the second bookkeeper of the firm, was employed. Then he stopped depositing the books and stole money from the G. O. orders and from the cash in the safe. He escaped detection, he said, when a balance was demanded by making up a false balance sheet.

He confessed that one suspicious footing of \$15,574 in the cash book was made up of small amounts of pilferings, and that another item of \$5,400 that could not be accounted for by the expert bookkeeper was made up of amounts introduced in the books to conceal still further peculations.

A cash book of the firm and Mr. Webster's private cash account book were missing after the discovery of Scott's dishonest work, but he did not think they knew his circumstances, and he said he had figured out to be worth \$50,000 all told.
