

PARSON DOWNS'S LAWSUIT.

HE HAS REAMS OF EVIDENCE, HE SAYS, TO OVERTHELM HIS ENEMIES.

After Mr. Downs had been convicted by the grand jury of conspiracy to blackmail his reputation and drive him from the pulpit, he would like satisfaction in \$25,000.

BOSTON, Aug. 15.—The Rev. W. W. Downs has come to the conclusion that there is a time to fight as well as a time to pray, and when he next appears in court he proposes to make things very hot for his prosecutors. He has hounded and persecuted him beyond the limits of Christian endurance. He has been smitten on both cheeks, and now he has taken off his coat with the intention of wiping up the ground with his persecutors. Conspicuously as his name has been used in connection with the scandal of August, 1885, Mr. Downs has never figured as a principal in any of the trials, retrials, and mistrials except in his suit for arrears of salary against the society of the Bowdoin Square Baptist Church, although practically he was in each case the defendant of his character and reputation. That role he has abandoned, and he is now the plaintiff in a suit for \$25,000 damages against the members of his alleged enemies. The suit, which has been mentioned in THE SUN, will be based upon what he believes to have been a series of conspiracies to ruin his reputation.

Mr. Downs has, from the first, stoutly maintained his innocence of the crimes of which he was accused, and when witnesses in court were decided against him he began a still hunt for evidence to prove that the charges against him were all false. The documentary evidence which he has secured fills a big roll-top desk, a large box, a trunk, and two big valises. He says it would take his innocence before the grand jury. If he is permitted to introduce one-half of the testimony he says he has, a great number of laymen and clergymen of the Baptist Church will be involved, and Mr. Downs thinks that, from the nature of his charges, a great number of them will be so regarded for the next fifty years.

The defendants in this suit are Joseph Thayer, John W. B. Thayer, John W. B. Thayer, Joseph Thayer, Dr. Rufus H. Noyes, Mrs. Abbie Campbell, and Alice Nepton, alias Watson. They may be brought in one by one, and the trial, and other suits of a different nature, may be brought against various persons.


