

A BLOW AT THE COMMISSION.

THE SUPREME COURT DIMINISHES THE CASE AGAINST COUNSELLMAN.

The Interstate Commission Cannot Compel Him to Testify Against the Railroads, Because He Claimed that It Would Criminalize Himself—Neither Is a Person Required to Give Any Information Which May Be Used to Obtain Evidence Against Him.

WASHINGTON, Jan. 11.—The United States Supreme Court today decided in the case of Charles Counsellman of Chicago against Frank Hitchcock, United States Marshal, in the Northern district of Illinois, that the Interstate Commerce Commission has no right to compel Counsellman to testify against himself, and that it reverses the decision of the United States Circuit Court for that district, which held that Counsellman in refusing to answer questions put to him by the Interstate Commerce Commission was guilty of contempt.

The Commission was asked by the Commission whether the railroads had discriminated in favor of their own rates to shippers. He refused to answer on the ground that he would incriminate himself.

The Commission, in reversing the case to the Chicago federal court, held that Counsellman also had a right to answer on the same ground. The reversal of the Supreme Court today decided that Counsellman was not guilty of contempt and that the order committing him to the custody of the United States Marshal was not valid.

The decision was handed down by Justice Blatchford. It orders that the decision of the circuit court be reversed and that Counsellman be discharged.

Senator Callahan and other friends of the Interstate Commerce law expressed considerable concern as to the probability of the decision of the Supreme Court in the Counsellman case. They fear that the practical effect of the decision may be to afford all witnesses called before the commission to testify in regard to alleged violations of law, a loophole of escape from giving evidence.

There must be some way of protecting the public interest in the law is a dead letter. Until I have seen the full text of the decision I am not prepared to talk about it in detail. I trust the matter will be taken care of in some other way. It seems serious as it stands.

Here are the main points of the decision: It is held that the Interstate Commerce Commission is not entitled to plead the privilege of a witness in a criminal case against himself, but such is not the language of the Constitution. It is held that a person is not compelled to testify in any criminal case, but a witness against another person is not a witness against himself. This conclusion is in favor of the right which it was intended to secure.

The matter under investigation by the Interstate Commerce Commission was whether there had been a criminal violation of the Interstate Commerce law. The Commission was asked to present to the grand jury, and he himself was not to be a witness against himself. The case before the grand jury was, therefore, a criminal case. Counsellman himself and he would be compelled to give them in a criminal case.

It is impossible that the meaning of the constitutional provisions can only be that a witness shall not be compelled to testify against himself in a criminal prosecution against himself. The object was to insure that a person should not be compelled, when he is a witness against another, to give testimony which might show that he himself had committed a crime.
