

PETER F. MEYER WRATHFUL.

WELL AFOOT OF THE PRESIDENT OF THE BOARD OF EDUCATION.

Mr. Meyer is on the jury in the Solomon Case, and Mr. Sanger Objected to His Questions—Quotations on Divorced Parents at the Long Branch Marriage Exchange.

One passage of Henry Solomon's testimony was amusing. In reply to a question he said he had talked to David about his ability to marry. He had told David that he ought to get married in one of his letters to David from Saratoga.

CANADA'S GOVERNOR-GENERAL.

Lord Aberdeen Takes the Oath of Office—The Leave at Quebec.

QUEBEC, Sept. 18.—In the presence of Sir John Thompson, from among the members of the Dominion Cabinet, and a large and brilliant assemblage, the Earl of Aberdeen was to-day sworn in as Governor-General of Canada. The ceremony took place in the legislative council chamber, in the provincial Parliament building, and the oath of office was administered by Justice Sir James Strong of the Supreme Court.

Gen. Sir John Montgomery Moore, who has been administering the affairs of the Dominion since the departure of Lord Stanley, occupied the throne in the council chamber. Cardinal Taschereau occupied the first seat to the left, with Vice-Governor Marois, Chief Justice Gwynne, and Sir John Thompson at the central table were Sir John Thompson and the following members of his Cabinet: The Hon. John Haggart, Sir A. P. Caron, Sir Charles H. Tupper, the Hon. J. Costigan, and the Hon. A. G. D. B. Cameron.

His Excellency, on his installation, which was attended by a Governor-General, was saluted by a detachment of artillery stationed there, the band playing the national anthem in both English and French, after which he and the Countess held a levee.
