IS THE MURDERER AN INDIAN?

A CHEROKEE FLEES FROM THE SCENE OF THE RICHLEY TRAGEDY.

A warrant for his arrest failed to find him after a reporter had interviewed him—Circumstantial Evidence in the Shape of Money and Tobacco Strong Against Him—Reporters Got the Clues.

Newtown, Pa., Sept. 26.—The two first suspects in the murder of the woman who was killed in the Newtown farm-house were Samuel M. Rightley and his wife Lena in their little farm-house home at Holland, about two miles from here.

The authorities are weaving a strong chain of circumstantial evidence around him. A warrant has been sworn out for his arrest, but he has fled to the mountains.

The clue which involves Durt is a piece of plug chewing tobacco which was found in the yard of the Rightley house under the window which the murderer entered.
