

THE WRECK OF THE JASON.

SAMUEL EVANS THE ONLY SURVIVOR--NO BODIES RECOVERED.

Evans' Story of the Voyage from Calcutta--Capt. McMillan Had Had No Observation for Two Days, but Thought He Could Drive by the Cape--Other Wrecks.

HIGHLAND LIGHT, Mass., Dec. 6.--When daylight came on this morning it was seen that the British ship Jason, which went ashore off Eastham in the storm yesterday afternoon, had broken in two amidstships. Her main and mizzen masts are gone, and every man of her crew on board, numbering 24, were washed into the sea and lost. Samuel J. Evans, her only survivor, who was washed ashore last night, tells this story of the voyage of the Jason:

"We sailed from Calcutta last February with a cargo of jute bales for Boston. Two days after leaving port we were nearly dismasted in a storm, and had to put into Mauritius for repairs. During that gale our mate was washed overboard and lost. After leaving Mauritius we had fair weather up to the equator. After Nov. 15 we encountered easterly gales with frequent squalls. On Nov. 21 we reached the Cape of Good Hope, and on the 23d we were in the South Channel last Monday and shared our course for Boston. On Tuesday morning the wind pulled out to E. S. E. and at 6 o'clock it began to snow. We had no observation for two days, but Capt. McMillan thought that we were off Cape Horn, and we kept our course. Toward noon the weather getting thicker, we took in all our upper sails and laid the ship along under three lower topsails and fore staysails. At 3:30 o'clock in the afternoon we made breackers right under our lee, and a few moments later we saw the great iceberg. We were in a narrow channel, and I tried to drive by the edge, but we had no sea room, and at 7:15, finding that we must soon strike, the ship was headed for the beach.

"The Captain had been long examining his charts. On reaching the beach he cried: 'We are lost. The ship is struck by the iceberg, and we all sprang for the lifeboats. Before we could cut the lashings the spars began to fall and the vessel to go to pieces. This was too much for the boys, and they all rushed for the lee mizzen rigging. Only half of them succeeded in gaining a footing. Some of them were swept overboard and were seen no more. I clung desperately to the rigging for a few moments when a great wave broke my grip and I went into the howling sea. I thought it was my end, but the water threw me here and there for a while, when suddenly I found myself on the sand. Soon men came and took me to the life-saving station. I am thankful that I am saved, but my poor shipmates are all gone. All of them had life preservers on, and I don't see why some of them could not reach the shore as well as I.

The King summoned Signor Farini, President of the Chamber of Deputies, and had a long conference with him. Zanardelli's decision to resign was hastened by Signor Farini's refusal to accept his resignation. Zanardelli's resignation was accepted by the King, and he was to be replaced by Signor Farini.

Signor Zanardelli had evidently counted upon having a holiday for several weeks in order to work up a majority in the Chamber. It appeared doubtful, in the face of the King's refusal to prorogue Parliament, if the Cabinet would risk a failure at the first sitting of Parliament. The attitude of King Humbert was interpreted to mean distrust of the Cabinet. He did not wish to make the throne an announcement of the imposition of new taxes, supported by a badly received Cabinet.

Lazard was taken to the New York Hospital, where he is now lying. He is in a precarious condition, and it is believed that he will not survive.
