

LINKS' RAWHIDE CANNON.

A STRANGE GUN TESTED AT SANDY HOOK YESTERDAY.

It Related a Pressure of 30,000 Pounds to the Square Inch. Apparently to the Disappointment of the Ordnance Board, and Mr. Link Declared She Was a Peach.

A rawhide cannon, the invention of a Frenchman named Frederick La Tull, living in Syracuse, was tested by the Ordnance Board of the United States army at the Sandy Hook proving ground yesterday. The cannon held its own against very much more than it was expected to.

The making down of the gun carriage was a disappointment to those who witnessed the test, and the members of the Ordnance Board were particularly annoyed by it. It prevented the other tests that the Board had decided upon, and it was believed that the reason they were so much disappointed was that the broken-down carriage they expected with these tests to blow the gun to finders.

Frederick La Tull, who invented the gun, has patented a rawhide boat and a number of other things made of rawhide, and two years ago began work on the rawhide cannon. He said it is the best gun he has ever made, though he admits the mention in history of a whole iron barrel, finally purchased a half interest in it, and paid the expenses of having it patented.

Mr. Link knows absolutely nothing about guns and freely admits it, but he is firmly convinced that the rawhide cannon is the weapon of the future, and he was who applied at Washington to have the Government test the gun. The War Department ordered the Ordnance Board to test the cannon carefully, and yesterday was the day set for the test. In Syracuse they have been firing the gun privately in an armory for a month past, and there, Mr. Link says, its most marvellous features were discovered. A National Guard gunner named Snyder operated the gun, and Mr. Link informed the Ordnance Board yesterday that Snyder was fully convinced that it was a great thing.

The principal claims made for the gun are that it is only about half the weight of an ordinary steel gun, that it is just as durable and strong as the steel gun, and that an enormous number of shots can be fired from it in rapid succession without heating it.

Two weeks ago the gun was sent to this city and transferred to the proving ground on the Government boat Ordinance. They have every kind of cannon imaginable at the proving ground, and the test of the rawhide cannon was the finest piece of the big guns than the men who make them, but when the rawhide product of Syracuse arrived they were utterly pleased. They had never seen anything like it, and they were all busy drawing lots as to who would conduct the test.

The authorities have every reason to believe that he committed the three murders in St. John parish, and perhaps is the murderer of the Uldos on Monday. The Italians along the coast are much alarmed by these murders. They all say that the Mafia is at the bottom of them.
