THE WILLIAM HORRE BLOW UP. The Boiler of the Tur Explosive and Engine-Driven Boat, the "Willam Horre," Exploded and Destroyed at the Mouth of the Gowanus Canal, on the 21st Inst. At an early hour yesterday morning the boiler of the tugboat William Horre, lying at the mouth of the Gowanus Canal, near the foot of Court Street, Brooklyn, exploded, and the boat was blown to pieces. Alonzo E. Lewis, the engineer, was killed, and Patrick and John Buckley, the ironman and deckhand, respectively, the only other two men aboard, escaped. The Buckley boys were asleep in the cabin at the time of the explosion and did not realize what had taken place until they found themselves side by side with the wreckage of the boiler. They clung to a mattress until they were rescued and brought ashore. No trace of Engineer Lewis could be found, but there is no doubt that he was killed. He had been ashore after the explosion and had been informed that when he returned to the tugboat, some of which were picked up hundreds of yards from the scene of the explosion, said that the boiler was probably blown to pieces and red-hot when the engineer turned on the water.
