WELL THUMPED AND JAILED. A sentence of one year in the Kings county penitentiary was imposed yesterday by Justice Gottling in the Lee Avenue Police Court, Williamsburgh, on Henry Abrams, the proprietor of the "Bumble-Loo" lodging house, at 57 North Second street, on the charge of striking Edward Parker, who lives at 923 Franklin avenue, on the arm with an axe. Parker has been attentive to Abrams' slighted and abused daughter, Abrams is opposed to it, and on Sunday night the two men had a row about it. Abrams, who has a wooden leg, was knocked down and kicked in the face. On Monday afternoon Parker went to the house at the invitation of Mrs. Abrams. Abrams saw him coming and locked the front door. Parker got in through the rear and Abrams ordered him out. Mrs. Abrams interfered and her husband and Parker got into a fight. When it was over Abrams' face was terribly bruised and Mrs. Abrams sent word to the 14th-avenue station that Parker was being killed, and a policeman who went there arrested Abrams. At the station house Abrams' injuries were dressed by an ambulance surgeon, and he was then held by Parker's complaint. Abrams' lawyer arranged yesterday in court he accused Parker of striking him with a hammer. He declared he was a doctor, and he believed Parker was surely going to kill him.
