

ARRESTED IN UNIFORM.

Former Captain of Volunteers Accused of Swindling. Issue T. Jobe locked up for procuring railroad tickets on forged government orders and disposing of them to scalpers arrested at the Astor House.

Issue T. Jobe, formerly a captain in the Sixth United States Volunteer Infantry, one of the famous regiment, was arrested yesterday morning before United States Commissioner Alexander on a charge of swindling the United States Government. He was held in \$2,500 bail to await the action of the United States Grand Jury.

On June 3, according to the complaint, he called upon J. B. Richardson, one of the proprietors of the railroad, at Broadway and Twenty-third street, and explaining that he was Capt. Guard of the Nineteenth Infantry, presented an order for the transportation of a sergeant and nine men to Western States.

Jobe could not give a satisfactory answer to the questions asked by the collector. He was taken to the station and held in the cell at the Astor House. He was released on bail of \$2,500.
