The defendant, who have not served their answers yet, will have to answer the allegation that the above is a correct description of the game of craps.

SOFT COAL UP FIFTY CENTS.

NO ADVANCE IN ANTHRACITE THOUGH, "AT PRESENT."

Retail Dealers Meeting Shy About Talking Prices in Public—But in Private Most of Them Would Like to Get All That Is Possible Out of the Consumer.

Retail coal dealers voted yesterday not to advance the price of anthracite "for the present" and directed the presiding officer of their meeting to appoint a committee to determine when "for the present" is past.

Methods of skinning cuts were discussed with much vim by the retailers in a hall at 131 East Fifty-eighth street.

Immediately the question of admitting newspaper reporters was brought up. Mr. Smoot said that their exclusion would be taken by the coal-consuming public to mean that prices were to be advanced without reason.

Mr. Curtis declared in his opening address that the situation was not unprecedented, but peculiarly critical.

"If the mouths of the dealers had been padlocked for the last week the trade would be in better shape now," said Mr. Curtis. This was greeted with deafening cheers by the unmuzzled.

Without debate it was voted to advance bituminous coal 50 cents a ton, making the price \$3.50. A week ago it could be had for \$2.12 1/2.

Members were then asked to give their views on the advance of anthracite. A singular failure to respond was credited to the number of those who had been made to shut their mouths.

Some said that if they had to buy coal now they would pay \$4.00 a ton. Others said that the public couldn't object to paying \$7.50 as that was what the dealers would have to buy at if they did so.

All the talk wound up with the adoption of a resolution as the sense of the trade that the situation did not require advance of prices "for the present."
