PRIVATE SALES, AUCTIONS AND PUBLIC RECORDS.

Former Alderman Louis Minsky Secures a Site for a New Apartment House—Lots in Demand at Marlboro—J. M. Levy Sells a Liberty Street Corner Plot.

The sale of lots at Marlboro is cited by Wood, Harmon & Co. as a good illustration of the great demand existing for lots in the outlying wards of Brooklyn. The tract was opened last fall and more than 1,200 lots have since been sold, at a total of \$700,000.

The conditions upon which the sales were made include installment payments with a non-forfeiture clause, free deed in case of death, no improvements free, and no tax paid for a certain period ahead. Wood, Harmon & Co. was the first large firm to undertake to sell real estate upon the installment plan. They have kept in the lead ever since. In Brooklyn they have sold over 10,000 lots at Oak Crest, Rugby, the Lindens, Kings Oaks, Kingsboro and Marlboro.

The streets leading through these properties are graded, paved, sidewalked with cement walks, and tastefully ornamented with selected shade trees. S. Steingut & Co. have sold No. 111 Second avenue, a three-story and basement house, on lot 2128, for Dr. J. Hoffman to former Alderman Louis Minsky, who recently bought No. 113, a similar parlor, through the same brokers. Mr. Minsky will build a six-story apartment house.
