

HEARST STIRS UP BIG CROWD

ATTACKS CARLISLE AND PARKER AT BROOKLYN MEETING

And Criticizes the Way Tammany Has Run Its Campaign Against It—Great demonstration at the Clermont Hotel, and for Blocks Along Tenth Avenue.

The campaign which William B. Hearst has been making practically closed last night in a glow of red fire and a trail of speckles that let in Brooklyn, too, in Little Italy in Harlem and went the length of Tenth Avenue. Mr. Hearst made eleven speeches and spoke to over 25,000 people. Possibility twice that number of people got a look at him for Tenth Avenue, was aimed by the people who cheered him. He spoke at several open air meetings on the avenue, but few could hear him. The din made by marching clubs and the shouting from the street and housetops was too much for any orator to talk against.

RUMPS OVER HEARST TALKER. He Dived Through Crowd to Thrash Boy—Crowd Took His Part When Cops Came.

A man who says he is "at present out of employment, but working for Hearst," caused a rumpus in the Tenderloin last night which was quieted only after Capt. Dooley had sent out his entire midnight patrol of force with their night sticks drawn and chased a crowd of several hundred persons from in front of the Tenderloin police station in West Thirtieth street.

The Hearst man, who gave his name as Flston H. Moffat and his address as the Stadium Hotel, Forty-third street and Sixth Avenue, started to speak at about 11:30 o'clock from the steps of the Union Trust Building at Broadway and Thirty-second street. More than 300 men gathered. Suddenly the Hearst speaker made a lunge into the crowd, and breaking through started down Broadway on the dead run after a small boy.

The orator overtook the boy at Thirty-first street and started to lambast him with his fists. A cop interfered and took the two to the station house. A crowd of 250 followed cheering. The crowd kept up the racket in front of the station house until Capt. Dooley became annoyed and appeared on the scene. He was greeted with a racket that almost raised the roofs in the neighborhood.

The car that whirled indignantly on his heels, ordered out the entire night patrol, consisting of twenty-four cops, who were waiting to be turned out on regular duty. The cops went at the crowd in earnest, swinging their sticks and threatening to strike until the trouble was over.

Moffat claims that somebody hit him in the head with an empty bottle. He thought it was the boy because he saw him running away. The crowd seemed to be laboring under the idea that Moffat was being persecuted, if it really had any idea.

Grumbling Leaders Take Their Pittances and Depart. It was dough day yesterday at Republican county headquarters. The Republican district leaders got much less than they asked for. It has been known all along that there would be very little money to be had out of this year from the Republican headquarters, but the leaders did not expect, according to the grumbling heard last night, that the Odell managers were so poverty stricken as the dough chest showed.

New Odell, if he can elect his man Speaker of the Assembly, is to repeal the law and return the franchise granting power to an Odell Board of Aldermen in New York City. The deal, if successful would strengthen Odell in Albany and in New York City. The Hearst men have endorsed thirty-seven candidates for Aldermen and there are six or seven Republican candidates without any endorsement who are likely to be elected. A majority of the board is thirty-seven.

Odell Republican district leaders who occasionally bet on the result of a campaign said that it was because of inside knowledge of this Odell-Hearst deal that not a single bet has been recorded except at the longest odds of the cam in all that Mr. Evans would be elected Mayor or that he would ever run second in the race. ODELL WANTS THE ALDERMEN

GIVE BACK FRANCHISE POWER TO A REPUBLICAN BOARD?

An Explanation of the B7 Hearst Endorsements of Republican Candidates Given by Odell Supporters—What Is Mr. Evans Going to Get? They Ask.

The Odell-Hearst deal on Assembly and Aldermanic candidates in twenty-nine Assembly districts in New York City was the talk of politicians yesterday. This deal extends to all the boroughs in the city save Richmond, and much credit was given to George Cromwell, President of that borough, because he would have nothing to do with it. The deal was engineered by Benjamin B. Odell, Jr., and his chief lieutenants in the New York Republican county committee, aided by Odell men in Brooklyn and Queens, and Mr. Hearst's personal representatives arranged many details which, it is alleged, were fully known to William M. Evans, the candidate of Mr. Odell's machine for Mayor.

Odell Assembly district leaders in the East and West sides of the borough of Manhattan sent out yesterday thousands of circulars to the enrolled Republicans in their districts which said: "If you cannot vote for William M. Evans for Mayor, vote for William B. Hearst and vote especially for your candidates for Assembly and Aldermen."

So far as is known Mr. Evans has not objected to the deal between Odell and Hearst, and just what he is to get out of the deal was one of the principal problems yesterday. Men intimate with Mr. Evans have said during the campaign that he has not had at any time the slightest idea that he is to be elected on Tuesday, and yet has been known to raise no objection to the fact between Odell and Hearst whereby Odell Republicans are urged to vote for Hearst for Mayor, in return for which Hearst is urging his followers to vote a straight ticket, which means to vote for Odell's candidates for the Assembly and the Board of Aldermen.

Odell Republican district leaders said yesterday that Hearst's vote on the East Side of Manhattan borough will be 80 per cent. Odell Republicans, and 20 per cent. Democratic, and that this percentage will prevail in all districts in Brooklyn, Bronx and Queens boroughs, where the Odell-Hearst pact is in force. The Odell Republicans made no secret of the purpose of the Odell-Hearst deal. Evans, they surmised, was not going to be disappointed as a result of it. They said that Odell was trying for control of the Board of Aldermen as well as of the Assembly, for this reason:
