HOW TO FLOAT CANAL BONDS.

THE PEOPLE MAY PASS ON THE QUESTION NEXT FALL.

Plan Agreed Upon to Amend the Barge Canal Law by Permitting the State Comptroller to Fix Rate of Interest—This Must Be Approved by the People.

ALBANY, March 7.—Indirectly the people of the State at next fall's election will have an opportunity of passing again upon the \$10,000,000 barge canal folly. As a result of the conference between the advocates of the barge canal and the leading Republicans in the Legislature with Gov. Hughes as to the best means of meeting the situation caused by the failure of the public to subscribe for the 3 per cent. barge canal bonds it has been determined to abandon the plan suggested by the barge canal advocates and to have the present Legislature pass a bill permitting the State Comptroller, and possibly the Governor and the chairman of the Finance Committee of the two branches of the Legislature, to fix the interest on the canal bonds at a rate ranging from 3 to 5 per cent., according to the state of the money market at the time the bonds are sold.

STATES SUBJECT TO LABOR LAW.

Attorney-General Bonaparte's Decision Regarding the Inducing of Immigrants.

WASHINGTON, March 7.—In an opinion made public to-day Attorney-General Bonaparte holds that the State of South Carolina did not violate the alien contract labor laws existing prior to February 20 last when its agents brought over from Europe some months ago 500 or more immigrants for employment in various lines of industry. The Attorney-General holds, however, that under the law approved by the President on February 20 aliens entering this country under circumstances similar to those of the importation into South Carolina would unquestionably be liable to exclusion.
