DEEP THOUGHTS PROVOKED IN EAST FOURTEENTH STREET.

OKLAHOMA AFTER ROCK ISLAND.

Attorney-General Prepares Three Suits and May Ask for Receiver.

GUTHRIE, Okla., Feb. 26.—Attorney-General West today filed suit in Oklahoma City to dissolve the merger of the Rock Island and Frisco railroads, alleging that it is an unlawful combination and prevents competition because both roads serve the same territory.

Another suit has been prepared by Attorney-General West against the Rock Island interests and was sent by him to-night to Tecumseh to be filed in the Pottawatomie County District Court.

The Rock Island Company, the Chicago Rock Island and Pacific Railway Company and the Rock Island Coal Company are named in another suit Attorney-General West has prepared for the separation of the transportation and the coal business.

Late to-night it was announced that at the request of Rock Island officials the Governor and Attorney-General had agreed not to push any of these suits until after they had conferred with the president and attorneys of the Rock Island system.

CONGO RULE MUST CHANGE.

If Belgium Won't Take a Hold of Reforms England Will Move.

LONDON, Feb. 26.—In the course of the debate in the House of Commons on the Congo question Sir Edward Grey, Foreign Secretary, delivered a more emphatic warning to King Leopold than did Lord Fitzmaurice, Parliamentary Secretary of the Foreign Office, in the House of Lords yesterday.

Mr. Edward said the only satisfactory solution of the question was the transfer-ence of the existing authority to some other country. Great Britain had done her utmost to encourage a genuine transfer to Belgium.

MARTOOGESSIAN POSES AS A PATRIOT ON WITNESS STAND.

Sure That the Grand Turk Has Compelled His Dealer Karagheusian to Prosecute Him for Extortion—He Borrowed Money, He Says, but He Didn't Extort.
