PROMISES CHEAPER LIGHTS.

Long Acre Company Renews Its Applications for Bond Issue Permit.

The Public Service Commission held another hearing yesterday on the application of the Long Acre Electric Light and Power Company to issue \$50,000,000 in bonds and \$10,000,000 in stock for the purpose of enlarging its plant in order to compete with the Edison company in supplying electric light to the theatrical district.

THE HEARING YESTERDAY

Henry W. King, one of counsel for the company, was examined. It was brought out by the company's counsel that the value of the assets owned by the company outside of the theatre district is \$24,000,000, and that from the small plant now operated by the company only six or seven buildings were supplied with current.
