

PRESIDENT TO METHODISTS

TALKS ON CLEAN CITIZENSHIP AND BIG FAMILIES.

Delegates to the General Conference at Baltimore Go to Washington and Meet at the American University—President Praises the Church's Pioneer Work.

WASHINGTON, May 16.—More than a thousand Methodists who have been attending the General Conference of the Methodist Episcopal Church in Baltimore assembled at the American University, near Washington, to-day as guests of the officers of the institution. The visit was primarily for the purpose of hearing an address by President Roosevelt.

The Methodists came over from Baltimore early this afternoon in two special trains. Bishop Cranston and other distinguished leaders of the Church were in the party and there were a large number of laymen as well as ministers representing churches in every part of the country.

The university grounds, where the afternoon's exercises were held in the open air, are on the heights west of Georgetown, and President Roosevelt drove out to the place in the White House carriage.

He reached the grounds a few minutes before 3 o'clock and was received with applause by the assembled Methodists. He spoke from a temporary pavilion which had been erected near the Hall of History building.

The President said in part: It is a pleasure to be with you to-day and to bid you welcome on behalf of the nation, here in the capital of the United States. The Methodist Church is in many lands there is none in which it has played so great and peculiar a part as here in the United States.

To nation in the world has more right than ours to look with proud confidence toward the future. Nowhere else has the experiment of democratic government, of government by the people and for the people, of government based on the principle of treating each man on his innate worth as a man been tried on so vast a scale as with us; and on the whole the experiment has been more successful than anywhere else.

Moreover, on the whole I think it can be said that we have grown better and not worse, for if there is much evil still growing about us, and if wrong grows so in even greater measure grows the sense of right before which wrong must eventually yield. It would be both unmanly and unwarranted to become faint hearted or despairing about the nation's future.

Clear eyed and far sighted men, who are alive to the heart and soul of the nation, for a moment refusing to see and acknowledge the many evils around us must yet also feel a confident assurance that in the struggle we shall win and not lose, that the center has just opened will see great triumph for our people.

But the surest way to achieve this triumph is while never losing hope and belief in our progress yet at the same time endeavoring to curb and curb what is evil in the progress of the many forces working through and with and against one another in the up-building of our social structure.

There is much that tends toward evil as well as much that tends toward good; and the true patriot is that man who without losing faith in the good does his best to combat the evil, to stamp it out where that is possible and at least to minimize its results. Prosperity and good have come to us through the material basis of national greatness, inevitably tend to undue exaltation of the merely material side of the national character, and we must largely rely on the efforts of such men and women as those I am addressing to build up the spiritual life, without which the material life amounts to nothing.

As generation succeeds generation the problems change in their external shape; needs vanish and new needs arise. It remains as true as ever that in the last analysis national greatness, national happiness, national success, depend upon the character of the individual man and individual woman. We need good laws, but we need the laws honestly and fearlessly administered; we need wealth, we need science and art and all the kindred activities that spring from the clever brain and the deft hand, but most of all we need the essential qualities that in their sum make up the good man and the good woman; most of all we need that fine and healthy family life, the lack of which makes any seeming material prosperity but a glittering sham.

If the average man is brave and hard working and clean living, if the average woman has the qualities which make a good wife and good mother, if each has self-respect and each realizes that the greatest thing in life is the chance to do service—why, then the future of the nation is secure. News reached this city yesterday that the contract for the new bridge over the Nile at Cairo which will cost more than \$1,500,000 has been signed by the Ministry of Public Works with the Compagnie de Fives-Lille of France, after an international competition in bidding for its construction.

The new bridge, which will be located at the deepest part of the Nile and will lead direct to the site where the Boulou Museum stood, is to be built in accordance with plans prepared by the late Sir Benjamin Baker of London, the engineer of the great Forth Bridge, Scotland, and the Scherzer Rolling Lift Bridge Company of New York, the latter company also furnishing consulting engineering services during erection.

The entire work is to be executed under the charge of the Ministry of Public Works of the Egyptian Government and it is expected that the bridge will be completed before the end of 1910.

The bridge will have a total length between abutments of about 675 yards. The total width of the bridge will be about sixty feet, and be divided into two footpaths of ten feet each, a roadway of fifteen feet to carry double lines of electric trolley cars, three foot gauges, and twenty-three feet of roadway. The structure will consist of a Scherzer rolling lift bridge with four fixed approaches.

On the Boulic side of the Nile quay walls will be constructed on masonry walls. The south end of the abutment on this side of the river will be built on concrete and the north end will ultimately be joined to the quays under construction. The pier and abutments, which will be of associated granite, are to be built on foundations to be sunk by compressed air. The Scherzer rolling lift bridge will have a movable span of about seventy-five yards to allow the passage of boats.

In order to facilitate the heavy water and land traffic at this site, which is in the most prominent part of the Egyptian capital, the lift bridge is designed to operate very rapidly, the time required to open or close it being less than thirty seconds. This result is accomplished by the use of electric equipment.
