Poston, April 14.-As was expected, William, C. Russell of Melrose took the public into his confidence this morning to the extent of forty-three words, a statement acknowledging the man generally known as "Fresno Dan" to be long missing brother. Daniel Blake Rus-The statement reads:

"Boston, April 14, 1910. that I am convinced and satisfied that Daniel Blake Russell, who has recently come to Boston from Fresno, Cal., is the son of my father, Daniel Russell, late of Melrose, and is my own brother.

"Fresno Dan" has made affidavit that he is Daniel Blake Russell and that he never heard of the contest waged here for so many months over the Russell estate until February 21, when he read a story outlining the case in a Fresno newspaper.

On Washington's Birthday he read a similar story in the San Francisco Chronicle, and on the next day, February 23, he went to Ben Drenth, a city detective of Fresno, and told him he was Daniel Blake Russell, although for seventeen years he had been a laborer under the name of Henry Johnson.

Drenth was so impressed with the man's story that he took him to the office of Senator George W. Cartwright, one of the most prominent lawyers in Fresno,

of Senator George W. Cartwright, one of the most prominent lawyers in Fresno, and after several days of questioning Mr. Cartwright became convinced of the man's story and wrote a letter to William C. Russell at Melrose.

Senator Simpson, counsel for "Dakota Dan." expressed no surprise over the statement from W. C. Russell. He said:

"I knew as long ago as last November when the detectives appeared in this case that at the proper time, as they stated, they would produce a real Daniel Blake Russell. Now he is here and has been recognized.

"It seems passing strange that with all the publicity given this "Fresno Dan' and after the five days of deliberation and cross-examination that he could not recognize him before he did. There is something back of it all. I am not surprised or dismayed at this new step. We will fight to a finish."


