

DAVID W. BISHOP A SUICIDE

HEALTHY NEW YORKER SHOT HIMSELF IN PARIS.

Suffered From Nephritis, but His Friends Here Did Not Know He Was Dependent—Kept Doctor Waiting as He Ended His Life—Great Traveller.

PARIS, Dec. 2.—David Wolfe Bishop, it was learned to-day, committed suicide by shooting himself in the head at his home in this city yesterday.

The physician who had been attending Mr. Bishop had been apparently cheerful in the morning. At luncheon he told his secretary that he intended to visit his mother in America and would afterward spend the winter in Florida and Cuba.

Mr. Bishop was born in New York on December 25, 1875. LENOX, Dec. 2.—A cable message received to-night says that David Wolfe Bishop, whose death in Paris, where he had lived for eleven years, was reported last night, had committed suicide by shooting himself.

Mr. Bishop said he had no knowledge of any trouble or circumstance which would lead his brother to kill himself. The last letter David Wolfe Bishop wrote him was received on Friday, informing him that he was in good health and speaking of his prospective departure for New York, where he expected to spend the winter.

During the summer and autumn on the Continent Cortlandt Field Bishop saw much of his brother in Paris and also visited him at his home in Lenox. He was then in fine spirits and was enjoying fully his very beautiful property, which is near Reims.

Friends of Mr. Bishop in Lenox say he had an ample income to live on and gratify every desire. He was not of a dependent nature. He was exceedingly fond of his mother, Mrs. John E. Parsons, and expensive gifts for her reached New York often from various countries where her son was travelling.

Mr. Bishop, who was always an enthusiastic motorist, resisted arrest for speeding at Monte Carlo in 1903. He explained that he supposed the officers were foot-pads.

WALL STREET, ATTENTION.

Mrs. Sophia Loebinger Will Address You in the Afternoon Soon.

Mrs. Sophia Loebinger, secretary of the American suffragettes, has applied to the Police Department for a permit to hold a meeting in front of the Sub-Treasury building on Tuesday afternoon at the close of the stock market.

"No, a bit," she replied promptly. "I've been down there before, and I'm not all nervous at the prospect of trying to agitate the market."

WOTE BUYING EVIDENCE LOST.

Envelope Impounded by Court Contained Only Useless Papers.

NEW BEDFORD, Mass., Dec. 2.—When a sealed envelope supposed to contain the record of the inquest held by Judge Frank A. Milliken of the New Bedford District Court in 1909 into alleged vote buying here was opened by the Judge this afternoon in the presence of two members of the State police it was found to contain nothing but some old court papers that had no bearing on the inquest.

After the 1909 inquest was over, the citizens' committee which was behind the first investigation endeavored to have the record made public, but failed, and when Mr. Walsh asked Judge Milliken for the papers some days ago he got a refusal. This was reported to Gov. Foss, who wrote to Judge Milliken last Wednesday requesting him to give the State police access to the testimony, and to-day the Judge decided to accede to the request.

Today when the State officers went to Judge Milliken's office he said: "I have just written to the Governor a letter in which I state that I was ready to accede to his request. I will allow you as representative of the Governor to examine this evidence."

When the seals were broken the Judge was much surprised and, calling Clerk W. J. Adams, in a fruitless search in the latter's files.

FOLK'S PROTEGE NABBED.

He and Another Man Fall in a Holdup Job in Brooklyn.

Two young men, one of whom had been befriended by Gov. Folk of Missouri, were taken to the Adams street police station yesterday and locked up on charges of assault with intent to rob. They had beaten Samuel Holzwasser, a haberdasher, of 232 Fulton street, into insensibility before they were scared off by two detectives.

One of the young men was booked as David Walker, 18 years old, of St. Louis, Mo. His right name is Charles Wilson, it is said, and this seems to be borne out by a letter of recommendation which was found in one of his pockets. It bears the stamped signature of Gov. Folk. The prisoner said he had been employed for a while as stenographer to Gov. Folk's secretary.

The letter is typewritten on the stationery of the Governor of Missouri. In it Gov. Folk says that he saw Walker as a captain of a company of cadets at the Missouri Military Academy, and that he was known as a member of the Missouri Eastern gang but the police never got him in connection with any of the activities of that organization. Later he was said to have joined the Paul Kelly outfit.

WON'T BE LIKE SHERMAN LAW.

Canada Wants Anti-Trust Law That Won't Kill Business—Tariff Outlook.

OTTAWA, Dec. 2.—In answer to formal questions from the opposition, Prime Minister Borden and Minister of Finance White have made formal statements about the policy of the Government on several matters of international interest which will be taken up in the House of Commons almost immediately. As to the permanent tariff commission Mr. Borden's statement is:

"Authority from Parliament will be necessary and a measure will be introduced accordingly as early as possible."

As to the bounty on steel rods which expired July 1st, the Minister of Finance makes a formal statement that the Government has not yet considered a renewal, and as to the other bounties, such as the proposed bounty on pig iron, he says:

BAD MAN RIDDLED AT BALL

JULIE MORRELL, GUN FIGHTER, IS SHOT DOWN AT DANCE.

Gangster Goes to Stuyvesant Casino Pistol in Hand—Dozen Huskies Huddle Him as Bullets Fly, and Bravo Is Hurled to Street Dying—His Record.

Word was brought to the "Boys of the Avenue" at a ball of their giving in the Stuyvesant Casino at 149 Second avenue early yesterday morning that Julie Morrell, one of the type known to the police as gun fighters, was on his way to the Casino with the professed intention of starting something. The report as it was circulated about the hall varied. One version had it that Morrell was going to clean out the whole party, while the other suggested that he was after only one individual whom he expected to find there.

Morrell went to the Casino. He climbed the stairs and as he entered the door he was surrounded by a dozen or more husky young men who sought to frisk him. But, so the stories told say, his gun already was in his hand. There was a rough and tumble fight, then a number of shots and Morrell went sprawling down the stairs again.

The gangster was found on the pavement in front of the Casino by one of several detectives who were on their way to the dance to see if there was anybody there whose presence was wanted at Headquarters. Morrell, who evidently was badly hurt, said that somebody had hit him with a rock. At Bellevue, where he was taken in an ambulance, it was found that he had several bullet wounds. So far as the physicians could judge, the full feed of a revolver had been emptied into him. He probably will die. He insisted that he did not know who shot him.

By the time the detectives got upstairs in the dance hall it was cleared of all the dancers. The detectives heard that Morrell had been shot with his own revolver, wrested from him by the volunteer reception committee which had waited for him at the door.
