Pierpont Morgan, Jr., and their children, Mr. and Mrs. Herbert Sartorius, Miss Anne Morgan and J. Pierpont Morgan on the pier.

It was noted that practically all his family was with him, including his grandchildren, and that the leave-takings were unusually cordial on the part of the men and affectionate and tearful on the part of the women.

OLD WHALING MASTER DIES.

Capt. Coffin One of Last Three Famous Mariners of Nantucket.

BOSTON, Dec. 30. Capt. Edward B. Coffin, one of the last three surviving whaling masters of Nantucket, died there on Friday at the age of 86. He was known as Captain Coffin when at 17 he left Nantucket on his first whaling voyage in the bark Peru, which sailed from Nantucket on May 19, 1845. This first experience on a whaleship covered forty months.

In May, 1860, Capt. Coffin was given his first command, that of the bark Sapho of New Bedford. It was a Pacific Ocean cruise, and in the three years he was out Capt. Coffin took 1,400 barrels of sperm oil. Three months later he was at sea again in the same ship and in less than three years he had filled the vessel with sperm oil the sale of which netted him a little more than \$10,000.

Capt. Coffin made his last voyage in command of the ship Mount Wollaston in 1887 for the Pacific Ocean and returned with a record of a 200-barrel yield of sperm, another profitable voyage.

He then engaged in farming on a small scale until increasing years compelled him to give up active pursuits.
