U. S. CITIZENS GERMAN SPIES? "Pettit Journal" Would Prevent Naturalization of Suspects.

Special Cable Dispatch to The Sun. PARIS, Oct. 5.—The Pettit Journal, after pointing out that the Government's recent revision of the laws permits that residence be granted to Austrians and Germans, demands that stronger measures be adopted against spies.

The paper says the usual means adopted by German spies is to obtain American, Swiss or French naturalization papers. It says Germans who are naturalized as Americans or Swiss ought to be expelled from the country.

"If such citizens are merely scratched," the Pettit Journal continues, "a German spy is discovered ninety-nine times out of a hundred. Let the widest hospitality continue to be accorded to authentic Americans and Swiss, but clear out those made in Germany."

Wouldn't Be Wise for Him to Withdraw Attention From National Campaign.

BRYAN HELPS CAMPAIGN

William F. McCombs telephoned to Gov. Glynn yesterday that he could not take the chairmanship of the Democratic State committee.

Mr. McCombs made it plain that he will help the State Democrats in every possible way. He has already obtained from William J. Bryan a promise to make a speech at a big meeting in this city toward the end of the campaign.

At the same time that Mr. McCombs announced his decision President Wilson made this statement at the White House: "In my judgment Mr. McCombs has done the right thing. It would not be wise for the national chairman to withdraw his attention from the national campaign to conduct a campaign in a single State."

It can be said with authority that this does not indicate any lukewarmness on the President's part toward the New York candidates. Democrats here and in Washington expect that Mr. McCombs, with the approval of the President, will give special attention to the New York campaign, although not officially connected with it.

Confident of Clear Cut Victory. "While I should be extremely pleased," Mr. McCombs said, "to act as chairman of the Democratic State committee and to accede to the wishes of Gov.
