

Federal League Meets Here Today--Cornell and Brown Eleventh For Battlefield

COMPROMISE IN AIR AS FEDERALISTS GATHER But Secret Is Well Guarded, If Indeed, Magnates Know What Is to Happen.

MEET AT BILTMORE TO-DAY Less than two weeks ago the Boston Braves rang down the curtain on the 1914 baseball season by taking the fourth straight game from the proud Athletics today at the Biltmore Hotel the suave James A. Gilmore and his Federal League associates will try to ring up the curtain of the 1915 campaign.

Some sort of compromise between the Federalists and organized ball is in the air. The fact has been established that representatives of the rival factions have met already. Organized baseball will go no further than to insist that its meetings be held in the Biltmore Hotel. August Herrmann, chairman of the National Commission, admits having received a visit from Charles Weeghman, the Chicago Federal League magnate, shortly after the world's series game.

One of the terms of organized baseball, which wishes to remain in the background, sized up the sentiments of his confederates in these words yesterday: "Organized baseball has seen its fight that it can afford to be generous in a sense. The public has shown that there is no demand for a third major league. Eventually the Federal League will be forced to the same position. It is not in dollars and cents, but to the fair name of the sport? Contract jumping already has cast its stigma. There is no prospect of anything more. The players are too independent."
