NEW TYPHUS SERUM FOUND.

French Scientist Treats Eruptive Form of Disease.

PARIS, April 4.—The discovery of a serum for the treatment and prevention of eruptive typhus was announced to the Academy of Sciences yesterday by Dr. Pierre Roux, director of the Pasteur Institute.

The discovery resulted from the researches of Dr. Nicole, director of the Tunis branch of the Pasteur Institute. Marked improvement has been shown by thirteen cases treated with the serum.

JANE ADDAMS ALSO PLANNING TO GO ABOARD CONFERENCE AT DETROIT.

DETROIT, April 4.—Prior to her departure for Stockholm to join the neutral conference for peace, Henry Ford had a talk today with Emily Balch. Jane Addams was also present.

"The conference cannot fail," said Ford today. "Peace is the greatest thing in the world, and I am satisfied with what has been done by the conference up to the present time and believe it will result in much good. If the delegates think best, I may go over myself in May."

Miss Addams explained that she was unable to sail on the "peace ship" last December because of her illness. She added, "I hope to go later, but I will under a strict diet by my physician's order."

It is quite probable that David Starr Jordan, who is going with Mr. Ford, will go to Stockholm in the near future.

CHICAGO DEMOCRATS GAIN.

Mayor Thompson Able to Elect Only 3 of His 17 Candidates.

CHICAGO, April 4.—Factional fights in the Republican ranks over the selection of a national committee at the primaries next Tuesday, at which time delegates to the national convention will be named, and the removal by Mayor William Hale Thompson of Dr. Theodore Sells, as head of the municipal utility and health department and the suicide of the latter, nearly brought a Democratic landslide in the Aldermanic elections in Chicago today.

Early returns indicate that the Mayor was only able to elect three of his seventeen candidates in normally Republican strongholds. Various organizations and reform societies wrote their estimate of the Mayor's administration by voting solidly for Democratic candidates.

TO SIFT COERCION CHARGE.

John Doe Action in Third District Primary Fight.

After a conference yesterday between Police Commissioner Woods and Magistrate Murphy in the Tombs police court it was decided that John Doe action would be instituted against the charges of intimidation against Deputy Commissioner Lord contained in a circular distributed throughout the Third Assembly district.

According to the circular, Mr. Lord was declared to be interested in the intimidation of voters at the primaries in the interest of F. H. Sullivan, brother of the late Big Tim Sullivan.

"If Deputy Commissioner Lord is guilty of intimidating voters he can be prosecuted under the election law," said Commissioner Woods. "If not, somebody may be prosecuted for libel."

According to the circular, if any deputy is using his office to intimidate voters I want to know it. If not I want the libelous circular withdrawn and proper reparation made.

Commissioner Woods yesterday questioned Cesar F. Barra, Deputy Assistant District Attorney John Cardone and B. P. Golden, members of the Timothy D. Sullivan Association, where the charges against Lord originated. None of the charges were denied, but the responsibility for a signed statement accusing Mr. Lord.

SOCIALIST LEADS FOR MAYOR OF MILWAUKEE.

MILWAUKEE, April 4.—Milwaukee apparently has returned to a Socialist Mayor. By a vote so close that a final result will not be known until daylight, Daniel A. Hoan, once a hotel cook, now a lawyer, seems to have been elected over G. A. Bading, non-partisan, by a majority of hundreds. This is the estimate on the basis of scattering returns. The Socialists, however, appear to have lost strength in the Common Council.

EDGAR T. BRACKETT WINS.

Retains Control of Saratoga Republican Organization.

SARATOGA, N. Y., April 4.—Former State Senator Edgar T. Brackett retained control of the Republican organization of Saratoga county today in the primary elections after being defeated by George H. Whitney to gain the county leadership.

He will have a clear majority of at least 75 per cent in the county and Senator Whitney will be deposed as county chairman next week. Because of the criticism made by Senator Brackett of Gov. Whitman, the latter thought all his influence into the fight against him.
