MRS. I. T. BURDEN DIES OF HEART AFFECTION

Many Years a Leader in Society and in the Activities of Grace Church.

Mrs. I. Townsend Burden, for many years foremost in New York society and in the activities of Grace Church, died at Carlton House, 22 East Forty-seventh street, yesterday afternoon of heart trouble. Her death was not unexpected.

Mrs. Burden, widow of I. Townsend Burden, born master and financier, was born Evelyn Byrd Moore of Baltimore, June 19, 1847. She was a descendant as well as namesake of the great Virginia family, Evelyn Byrd, and a member of the Carter family, famous in the old Dominion. She was married to Mr. I.
